#### **HARDING TOWNSHIP HEALTH DEPARTMENT**

The Health Department has scheduled health clinics for 2002.

The **female cancer detection** program, for female residents who are at least

18 years old, will be held on **Thursday, March 21 and Thursday, March 28** from 8:30 AM to 12:00 Noon at the Municipal Building. Registration will be from February 28 to March 15.

The **adult health early-detection** program will be on **Thursday, April 18** from 8:00 AM to 12:00 Noon. This will be the only adult health screening held this year, so even if you attended the screening in October 2001 you are eligible to attend. This program will include blood tests, blood pressure and eye exams. Registration will be open from March 14 to April 10.

The date for the **male cancer detection** program is tentatively scheduled for **Tuesday March 12**. The exact date and time is yet to be determined, depending upon the availability of the doctors. You can call the Health Department at (973) 455-7296 after February 15 and March 1 to register and for more details.

The Health Department is sponsoring a **stroke clinic** presented by the Atlantic Neuroscience Institute and the Health Care Foundation of NJ on **Saturday, May 18** from 9:00 AM to 12:00 Noon. Tests will include blood pressure and carotid artery pressure testing. Counselors will be available to discuss the various risk factors for strokes. All persons older than 18 years are eligible to attend. Registration is from April 24 to May 10.

Notices for all clinics will also appear in the *Observer-Tribune*, the *Daily Record* and on the bulletin boards on the first floor of the Municipal Building, on the public notice board on Village Road, in the Post Office, and at other sites around town. Space at all clinics is limited. You may register in person at the Health Department on the second floor of the Municipal Building on Blue Mill Road or by phone (973) 455-7296. Registration hours are 9:00 AM to 3:00 PM.

**Blood pressure screening** is performed twice a month, on the second and fourth Thursday of the month, before the Harding Seniors' meeting at the Presbyterian Christian Education Building. The screening is open to all; you do not have to be a senior or a member of the group to have your blood pressure taken. Blood pressures are taken from 10:30 AM to 11:00 AM.

#### **Harding Township Municipal Alliance Chairperson Needed**

The group, which includes representatives from the Harding School, the Police, the PTA, and the Township Committee, meets to assess the Township needs, using police statistics, in the area of alcohol and drug abuse, and to plan projects dealing with the needs, including group discussion/education meetings for parents, with follow up to parents, seeking to know how parental supervision practices change. The Municipal Alliance is an organization created under NJ state law, and funded through a combination of County funds collected for drug offenses,

Harding Township municipal funds, and private donations. The goal of the Alliance is to acknowledge concerns about drug and alcohol abuse, not to deny them, and to deal with them in a responsible and productive manner.

Do you know how much this group has done for the children and the community? For the past 10 years, it has contributed over \$65,000 to fund Harding Twp School dances, school trips to ski resorts, Great Adventure, and to Sports and Games. It has funded Red Ribbon Weeks, the school alcohol and drug surveys, the BABES curriculum for third graders and the Willow Tree teen institute for the middle school age children. It has supported community Senior Information Luncheons and Media Efforts to raise awareness, and brought nationally known educational figures to the school for presentations. They are currently funding the Tuesday evening Positive Parenting Series.

This was very much appreciated by the American Red Cross and by the recipients of this blood because the Blood Bank was extremely low on inventory after the holidays.

### **TOWNSHIP NEWS** **Township Committee**

In January, a proposed ordinance 1-02 was introduced by a 4-1 vote. It is intended to place new limits on the maximum building areas in the R3 and R4 zones. For R4 the max bldg area would be 2100ft<sup>2</sup>, with a 15% limit. Currently the limit is 20%. For R3, the max is 15% and 1,500 on lots less than 15,000ft<sup>2</sup>; for lots between 15,000 and 37,500 ft<sup>2</sup>, the max would be 10% and 2,250 ft<sup>2</sup>; lots of 37,501 ft<sup>2</sup>- 87,120 ft<sup>2</sup> (up to 2 acres) would be limited to 6%, and 2,500 ft<sup>2</sup>. Lots between 2-3 acres would be 3% and 3000 ft<sup>2</sup>. Above 3 acres, there would be compliance with the R1 zone. John Murray voted against introduction of the ordinance. Murray, a resident of Mt Kemble Lake, voiced concern with the formula. Other residents living in the Mt Kemble Lake section voiced objections to the limits as applied to the Mt Kemble Lake development. Officials are considering a separate, new zoning district for the Mt Lake section, currently in the R4 zone. Other residential areas included in R4 are parts of Millbrook Rd, and the more densely built areas along Village and Dickson's Mill Rd. The Township planner, Susan Kimball, testified that lowering the building area limits in the R4 zone would make 37 of 173 lots non-conforming, compared to 12 presently. The R3 zone includes several areas in New Vernon and Green Village, as well as part of Sand Spring Rd and the Jenks Rd neighborhood. Out of the 144 lots in this district, 53 would be non-conforming, compared to the current 15.

The ordinance is intended to limit the number of excessively large homes on unacceptably small lots. This is partly in response to the trend toward larger houses, but especially those on small lots. Some people attending the meeting were especially concerned about a recent application on Millbrook Rd to build a house that neighbors feel is out of character and scale with the surrounding historical area. At least 30 residents have written to Council about the proposal, which would have small setbacks and a large building footprint.

For **November** meetings of the Township committee, a supplemental report follows:

In the meeting on **November 7<sup>th</sup>, 2001** the following resolutions were introduced and passed at the monthly agenda meeting:

Introduction of Ordinance No. 19-01, which amended Chapter 105 (Land Use and Development). This ordinance refers to flood prevention along the Passaic River. The Township Engineer reviewed the pertinent portions and concluded that in order to have the Township continue participation in the National Flood Insurance Program, the ordinance must be adopted to comply with changes required by the Federal Government.

Authorizing Refund of 2000 Taxes for Block 39, Lot 5, which the bank paid in error.

Authorizing Refund of 2001 Taxes for Block 11, Lot 4. This veteran's deduction was in the amount of \$150.

Authorizing Deletion of 2001 Taxes due to combining of lots or property reclassifications.

Supporting the Reauthorization of the Clean Communities Program in the amount of \$8400 annually to assist in curbside cleanup.

Approving Change Order No. 1 regarding Bayne Park Pond Dam which will extend the wall 5 feet to protect the trees. Repairs were also made to the footbridges.

Approving Insertion of Any Special Item of Revenue in 2001 Budget (Chapter 159) to enable an amendment of the budget.

Regarding the naming of the private road for the Ploetner subdivision, a motion was unanimously adopted to approve the name Coach and Four Lane.

Tax Assessor Pat Aceto updated the Committee on the revaluation. He explained that the last revaluation in the Township was in 1985, and that since that time land values for residential properties have increased on average 235%. He informed them that assessment value letters had been sent to approximately 75% of the property owners, and that hearings had begun. He estimated that an average assessment figure could be established by mid-December. Residents have until April 15<sup>th</sup> to appeal.

Mr. Aceto addressed the issues raised in Tiger Lily Lane resident Charles Sharp's September 5, 2001 letter concerning farmland assessments. Mr. Aceto explained how the farmland assessment program was administered, noting that the statute was mandated and enforced by the State. Annual applications must be made by August 1<sup>st</sup>, and proof of income by submission of receipts and tax returns. Mr. Sharp stated that he knew of instances in the Township where landowners were unlawfully applying for farmland assessment. The Township Attorney stated that if there was any evidence of fraudulent activity, it should be referred to the State

auditors.

Mr. Sharp also addressed the issue of house numbering for emergency 911 purposes. He discussed a numbering system based on distances from street intersections, explaining that the National Emergency Numbering Association (NENA) had guidelines for the development of such a system, which principally assists police departments in quickly locating homes during emergency situations. Mr. Sharp offered his assistance to develop such a project for the Township. He and Committeeman Murray will be meeting with the Township's GIS (Geographic Information System) coordinator, Chris Allyn.

**On November 28, 2001**, the following resolutions were introduced and unanimously passed at the Township Committee's monthly regular meeting:

Memorializing the Affirming of Grant of Use Variance.

Public Hearing and Adoption of Ordinance No. 19-01 – An Ordinance Amending Chapter 105, Land Use Development of the Code of the Township of Harding

Approving investment and reinvestments of Certificates of Deposit.

Due to a conflict, the Township Attorney recused himself from the discussion of the resolution memorializing the Animal Inn decision. Special Counsel Arnold Mytelka spoke on the content of the resolution entitled "Affirmance of Grant of Use Variance to Walter and Marianne Morris (d/b/a The Morris Animal Inn), Sand Spring Road, Block 23, Lots 8 and 12". Committeeman Lanzerotti recommended the deletion of the phrase in Item 2b of the resolution which stated: "because of the impact of Interstate Route 287" as he did not believe this factor was discussed in the context during the Township Committee hearing. The resolution was unanimously adopted by the voting members, which excluded Committeewoman Prendergast.

Committeewoman Farrell suggested that a memo be sent to the Board of Adjustment expressing the concerns voiced at the hearing in reference to the effects of lighting on adjoining properties. The other Township Committee members felt this issue would be dealt with during the site plan approval process since the Township Engineer attended this meeting and would be involved in the site plan stage.

The committee discussed the issue of Accessory Residences, which are permitted in the R-1 zones on 6+ acres. Township Planner Susan Kimball reviewed her October 29, 2001 memorandum. The Committee will review the memo and discuss this subject further in January 2002.

On behalf of the Environmental Commission, Chris Allyn requested authorization to apply to the State Department of Environmental Protection for an Office of Environmental Services matching grant to update the Township's National Resources Inventory. A motion was unanimously adopted.

Township Tax Assessor Pat Aceto updated the Committee on the

revaluation, and answered questions of the hearing process.

Committeeman Lanzerotti updated the Committee on the meeting he had held with Township Administrator Richard Wiedmann, Justine Kovacs and Frank Brown, consultant for the Ten Towns Great Swamp Watershed Management Committee, concerning the proposed project for Bayne Park Pond and Christ the King Church. He explained that, based on the assurance from Frank Brown, the project would be coordinated with Bayne Park plans of the Garden Club, Public Works and the Fire Department, he could now support the project.

### **PLANNING BOARD**, January 28

#5-01, DeCarlo, Tempe Wicke and Rt 202, Bl 34, lots 1 and 1.01, for adjustment of a lot line, was approved; the De Carlo pool will be removed, so the rear line setback issue has been minimized.

There was discussion about the letter Caron Menger, Chair, Shade Tree Commission, sent to Planning Board, asking that the Tree Conservation Ordinance protecting shade trees be extended to the R2 and R3 zones. Her motive was that tree conservation should be a priority in the entire town, not just parts of the town. Various protection limits were discussed, but the matter has been sent to the Advisory Review Committee of the Planning Board, who will research and report back to the Board. One of the ramifications of interest to the Board was whether the Mt Kemble Lake Subdivision should be made the subject of its own zone. No resolution of this issue was reached.

Ordinance 1-02, under discussion at the Township Committee, was found consistent with the Master Plan.

### **School Board News**

Monday, January 28th meeting

There was a presentation by the Speech and Language Services Therapist- Donna Auriemma. She is in the Harding School for those children who are in need of speech and or language therapy. Her credentials were outstanding and one parent praised her as well.

Next, the Turner Construction Foreman, Mike Nobel spoke regarding an update on the construction. He stated that the brand new water system failed twice for bacteria, the old system is still being used and is fine. They chlorinated the water and are hoping that this next inspection will be satisfactory. He also stated that they had to order new curtains for the gym, as they do not fit. He also stated that the back field is being graded now and will be reviewed by Dr. Pallozzi tomorrow.

Regarding the Principal Search, Mr. Salvatore Azzarello recently resigned, and he is one of three Principals at the Harding School that has resigned in the last four years. Once again mid-term the school is losing another Principal. Parents got



together in a forum setting and answered and discussed some topics regarding the Principal search that was run by Dr. Pallozzi. The results were very similar from five or more different groups. Number one concern is the longevity of the next Principal. Many of the surveys revealed that parents are strongly in support of having the second grade teacher, Dee Klikier, become the next Principal of Harding Township School. The Board has turned her down twice before when she applied. The parents stated that she would make an outstanding Principal, she knows the children, she knows how the school operates, she has been there for a long time and has the respect of the other teacher's and it would ease the burden of the school with yet another search. Dr. Pallozzi stated that he is still going to do a search regardless and thinks it is in the best interest of all. He also stated that they are hiring Ralph Celebre for one month as an interim Principal at \$400.00 / day. He can only stay one month because he has taken another position that begins in March.

The parents also expressed concern regarding the recently published ESPA scores for Harding Township School as well. Harding's fourth grade for the 2000-01 school year scored in the 71.9 percentile. These scores are substantially below the statewide average for similarly situated districts, ("J" schools). The scores are also significantly below all neighboring districts, including all elementary schools in Madison, Bernards Township, Morristown, Morris Plains, Mendham Boro, Mendham Township, and Chatham and far below those of other small schools like Alpine and Essex Fells, which have similar characteristics in terms of demographics and grade size as Harding Township School. The next Board Meeting will have the topic of the disappointing scores on the next agenda.

#### **BOARD OF ADJUSTMENT**, January 17

The following decisions taken last month were memorialized. The Board denied the application of Bard and Robyn Jacobson to construct a replacement residence exceeding the maximum building area of 3% 10% maximum lot coverage and 100' setback, in the R-1 zone. Property located on Millbrook Rd, Block 17, lot 12.

Approved variance of David Weil for swimming pool and pool patio in the rear yard, which will increase the lot coverage ratio to 12.1%. Also approved a request to renovate a preexisting barn located in front of the principal residence with a minimum front set back of 34', despite the building area ratio of 3.47%. Property located on Pleasantville Rd, Block 15, lot 20.

**ENVIRONMENTAL COMMISSION** The January 8 meeting was reported in the last Thumbnail.

#### **HARDING TWP HISTORIC PRESERVATION COMMISSION**, January 10

This was the annual reorganization meeting of the Harding Township Historic

Preservation Commission. Maureen Soter resigned her position on the Commission effective December 31, 2001. Maureen was commended for her excellent work on behalf of this Commission, especially her work preparing the Historic Properties Brochure. Wendy Montgomery, a member of the Township's Bd. of Adjustment, has been appointed to fill the vacant seat on this Commission.

The Historic Preservation Commission meetings will now be held on the 1<sup>st</sup> Thursdays each month, in the Municipal Bldg.

**OLD BUSINESS:**

- Block 48, Lot 7, Young's Road, Hanley residence. Mr. & Mrs. Hanley are requesting a very minor change in a sideline setback. The Commission recommends approvals without comment.
- Block 7, Lot 17, Nini, Millbrook Road. A letter from the neighboring property owners was reviewed. The neighbors outlined their reasons for not supporting the development of this property. HTHPC noted that many of their concerns were addressed in this letter.
- Block 17, Lot 14, Lombardi, Millbrook Road, returned to discuss and outline their new plans for a home on this property. Previous plans were abandoned for these featuring clapboard siding, more in keeping with the area. HTHPC appreciated the effort the Lombardi's made and suggested possible use of some original elements of the bank house in their new home.
- Block 26, Lot 12, Nicki and Stanley Doggett, Glen Alpin Road. The Doggetts presented new plans for the addition to their home. The design of the front window now reflects the period and character of the home.

**NEW BUSINESS:**

- Block 13, Lot 9, Hewitt, Historic Pleasantville district, Pleasantville Road. Plans presented to demolish the present dwelling.
- Block 27, Lot 7, Tomo, Mt. Kemble Avenue, possible historic easement reviewed.

**SHADE TREE ADVISORY COMMITTEE** has proposed that the 2001 Tree Conservation ordinance be applied Township wide, not just in the R1 (3 acres or more) zone, see Planning Board discussion above.

The Committee recently sent to all residents a summary of the Ordinance (passed in 2001, Ordinances #11-01, 15-01, & 17-01). *"On developed residential property 3 acres or more in size, a permit is required before a homeowner may cut down any tree 8 inches or greater in diameter which is located in the conservation area. The conservation area is comprised of a 50 foot wide perimeter along the portion of a property which abuts a roadway and a 25 foot perimeter along all other property lines. The 25 foot perimeter includes the "flagstaff" of a flag lot, except for trees designated to be removed to provide driveway access in accordance with an*

*approved permit. Please note that there is no fee for obtaining a tree removal permit for developed residential properties.*

“If any of the following exemptions apply, you will *not* need to obtain a permit for tree removal:

“Property not located in the R-1 Zone; In the R-1 Zone, all property located outside of the conservation area as defined above; Diseased or hazardous trees; Trees smaller than 8 inches in diameter as measured at a height of 4 ½ feet above the ground; Commercial orchards or nurseries; Trees in public utility rights of way, waste disposal and well system locations; Commercial farm that meets the requirements of the New Jersey Right to Farm Act.”

The group will provide a copy of the entire ordinance upon request, see the Township Administrator’s office, or write them at PO 666, New Vernon NJ 07976.

**The Garden Club** Congratulations to Justine Kovacs and Suzy Moran who represented the New Vernon Garden Club in decorating Drumthwacket for the holidays. They received the Core States silver bowl for artistic excellence for the dining room decorations.
