Annual Fire Department Auction Saturday, September 28th

Harding Township Annual Curbside Clean-Up

The Harding Township Committee announced that the annual curbside clean-up will commence on Monday, September 30th. Materials that will be collected include furniture, refrigerators (doors must be removed), rugs, small appliances and toys. Materials that will not be collected are tires, building material, garbage, stones, concrete, soil, brush, yard debris, toxic chemicals, propane bottles and tanks, 55 gallon drums (empty or full), oil tanks and oil based paints.

Lawn mowers and other gasoline powered equipment must have the gas and oil drained. Hot water heaters and water conditioners must be drained. Swing sets and similar equipment must be dismantled. Pipes and single pieces of lumber must be cut or bent into sections four (4) feet or less in length. Latex paint cans must be open with any paint dried out. Resident may place items at the curbside in front of their property no sooner than 10 days prior to the 9/30 collection date.

BOARD OF HEALTH

FLU VACCINE CLINIC

While a shortage of flu vaccine is not expected this year, there may still be delays in production and distribution. As in the past the Health Department will offer flu shots free of charge to eligible residents, however the dates cannot be determined until the delivery of the vaccine. We are anticipating holding the flu shot clinics late in October. Once the dates are determined, the health department will post notices in the Municipal Building, at the Post Office and on public bulletin boards in establishments around town. Notices will also be sent to the *Thumbnails*, the *Daily Record*, the *Observer-Tribune*, and the *Star-Ledger* or you can call the Health Department after October 1, 2002 at (973) 455-7296.

Flu shots are offered to all residents sixty-five years or older. Also, residents at high risk for flu due to chronic disease or those who are sole caregivers to the elderly or high-risk individuals may get a flu shot. High-risk residents must provide a note from their doctor, authorizing the vaccine, before the Health Department can administer the shot.

WATER RESTRICTIONS CONTINUE

The severe drought is having a direct impact on Harding residents. To date, eight wells in town have either "gone dry" or are producing less water than is needed. Harding Township relies almost exclusively on ground water as a water supply, most from private wells. Ground water levels are not visible, like reservoirs, ponds and streams, but the levels have been dropping. When the ground water level drops below the depth of a well, the well is dry. Short of drilling a new well or deepening the existing well, there is little that can be done. Therefore it is imperative that all residents conserve this most precious of resources. The Township Committee has reinstated all of the water emergency regulations that were originally imposed by the NJ Department of Environmental Protection in March. In general:

No watering of grassed areas is permitted with the exception of some limited watering of areas newly seeded or sodded as a result of new construction activity. The exemption that allows the use of water to wash in fertilizer, pesticide or herbicide is limited to once every six weeks.

Plants, trees, shrubs and vegetable gardens may be watered by means of a bucket, can or hand-held hose equipped with a nozzle which will shut off automatically when dropped. Any watering under this provision is not encouraged. Washing of vehicles, pavement, buildings or other surfaces is not allowed. Water may not be used for outdoor residential recreational or ornamental purposes.

Also, residents are encouraged to find and fix all leaks in the plumbing system, not to let the water run while shaving or brushing teeth, and to keep a pitcher of water in

the refrigerator so you won't be tempted to let the water run to get a glass of cool water. More water saving tips and a copy of the complete administrative order detailing the restrictions are available at the NJ DEP website: www.njdrought.org or at the Harding Municipal Building.

TOWNSHIP NEWS

Township Committee

The Twp Committee is exploring the possibility of hosting a ceremony to recognize Korean War vets who reside in Township. This is in response to the Morris Co Freeholders who have a project to identify all such vets, living or deceased, from Morris Co, and to present either them or their family members with a medal, to be presented at municipal ceremonies throughout the year. To be eligible, a person must have been or is now a Morris Co resident, on active duty between 6/23/50 and 1/31/55, and have received an honorable discharge. Registration is by calling Morris Co Dept of Human Services, 973 326 7286.

In July, issued bonds for \$1,714,000 for purchase of land on BI 51, lot 34.

In August, amended Land Use Ordinance, #11-02 by consolidating various checklists applicable to subdivisions and site plans. Passed, Ordinance #10-02, which accepts a gift of an easement on Bailey's Mill Rd, Bl 46, lot 4, for purposes of preservation, restoration and maintenance of the Bailey's mill race.

Planning Board

July 2002, memorialized approval of Lakeshore Co (#8-02) for minor subdivision with variance, Bl 36, lot 1, approved. (Mt Kemble Lake, Bailey's Mill Rd and Primrose Tr). In June, approved Kurdzialek, Pleasant Plains Rd for minor subdivision; and Premier for modification of major subdivision, Brook Dr N. No August meeting.

Board Of Adjustment

June 2002. The Chair, Mr. O'Loughlin, called the meeting to order at 7:40 PM on 6/20/02. Present were members Cameron, Eichler, Holdsworth, Montgomery, Scalera, and Viola, along with Board Attorney Gary Hall, Esq.

Approved, with minor editorial corrections, were Applications #9-02 (O'Loughlin), #10-02 (Desbrow), and #11-02 (Bistis-Niketas).

Pending Application #7-02, (Kuchler) was adjourned for an additional month.

Application #12-02 (Adler)-Block 15 Lot 23.01 and 23.02, which was the first request under the new Township ordinance controlling family member-non-rental-Accessory Residences, was approved; allowing a tennis court and accessory residence in front of the proposed new principal residence, on Pleasantville Rd

New Application #13-02 (Zonobini-Bakst)-Block 12 Lot 16 was given conditional approval.

New Application #14-02 (O'Connor)-Block 8 Lot 9 was approved, to allow enlargement of non-conforming residence by construction of a one-story addition increasing the total building area to 4,667 ft², notwithstanding the absence of a 150' setback on Village Rd.

July 2002. Approved the site plan for expansion of the Morris Animal Inn (#3-99) to a total of 14,800 ft² in order to accommodate 56 new units for larger dogs. Twp Engineer Fox concluded that the site plan and storm water management plan complied with the Board recommendations from earlier meetings.

August 2002 Request for amended variance approval, Tawnya Kabnick, Beach trail, Bl 38, lot 7. The original variance had granted a 25' setback for patio. Amendment requested for deck that covers patio and which is raised to height of kitchen floor. Site inspection date set.

New application #17-02, Forgione, Long Hill Rd, Bl 50, lot 8.01, request for C and D variances on new home, swimming pool, tennis court and detached garage. Proposal is for 14.7% impervious coverage, as opposed to the 10% allowed on the lot. Board asked applicants to return with a modified proposal.

New Application #18-02, Eichler and Mcfadyen, Blue Mill Rd, Bl 9, lot 9 (formerly Goetz), request for variance to renovate existing house and add family room and kitchen to rear. Variance required because existing house is outside building envelope and street frontage is less than 300'. Proposed building would be in building envelope. Application approved.

Approved application of Clew, BI 19, lot 10 for enlargement of non-conforming residence for rear patio, spa, with minimum west side setback of 92' and minimum east side set back of 62', property on Blue Mill Rd.

BOARD OF EDUCATION

The State is no longer providing money for mentoring first and second year teachers. Dr. Pallozzi is recommending that they go back to the way they used to fund the mentoring, (approx. \$500) the teacher's used to fund this through deduction of their payroll.

New Teacher Orientation is on 8/29/02.

This week they will be mailing actions plans for the goals this year. \$4600.92 will be applied to professional development and teacher materials. A research and writing project will be implemented. Title Five Drug Free "Project Alert" will be implemented for the middle school, cost is \$150.00 including activities, and assessments.

The Board has decided that children identified in each classroom as advanced academic achievers, will be given enrichment learning materials beginning with Math. Dr. Pallozzi proposed this, from the feedback which he received from the parents. Pam Fry has been hired as the new enrichment educator; she is a MA step eight and experience with gifted and talented programs.

The fourth grade Math ESPA results were just received and have not been reviewed yet. School will begin five minutes earlier this upcoming year; therefore the bus routes have all been rearranged to accommodate the required earlier time of arrival. There will be no exceptions for driving into streets and turning around when it is not necessary, unless

there is a Kindergartner on the street.

The PTO funded playground is complete, and will be ready for use on the first day of school. The B.O.E. will also be contributing money toward the grounds around the playground.

Railings are expected this week and will be ready by the first day of school as well. The new control system that is being replaced will help conserve energy as well. The third floor construction is going very well and is almost complete. The new construction company has been working out very well and right on schedule. Dee Klikier the new Principal, will be overseeing the incorporation of the curriculum in every classroom.

Madison High School renewal contract decision is due 12/31/02. This date can be extended if the need be. Discussions between Madison and Harding are continuing and Dr. Pallozzi has met individually with the Superintendent of Madison, Dr. Travlos as well. A letter is going out to all community members this week to inform the community of what the status is, and to invite all members of the community to attend the next meeting on October 14, 2002.
