HARDING TOWNSHIP BOARD OF HEALTH

FLU CLINICS: the **influenza immunization clinics** are scheduled **Thursday Oct. 23 and Thursday Oct. 30**, from 9:00 a.m. to 12:00 noon. The flu shots are available free of charge to Harding Township residents who are at least 65 years old and residents who are at high risk for flu due to chronic disease as defined by the CDC criteria. High-risk residents must provide a note from their doctor

authorizing the vaccine before the Health Department can administer the shot. The Health Department cannot give the flu vaccine to persons under 18 years of age. Parents who wish to have their children vaccinated should contact their pediatrician.

Residents, 65 years and older, who wish the pneumonia vaccine must call the Health Department at 973/267-8000, extension 148 to make an appointment. For future clinic information, please call the **Flu Hotline at 973/267-8000, extension 190.**

Eyeglass Collection: The Harding Township Health Department will again be sponsoring an eyeglass collection this fall. The eyeglasses will go to the Lions Club for distribution to those in need. TOWNSHIP NEWS

Township Committee Regular Meeting -- Sept 17, 2008

Attendees – (all) Barlett, Lanzerottis, Murray, Rybka, Ward

Ordinance - related to Eggert Property purchase – authorizes \$625K purchase and holds \$200K of the purchase price in escrow to cover remediation of the site – demolition of the house and bomb shelter and close well.

Resolutions – various resolutions passed including:

1. to hire a new deputy clerk, Amanda Gildersleeve
2. waive the noise ordinance during repair of the middle school roof, a 4 week job.
3. Execute \$750K grant agreement with NJ Historical Trust for work on Glen Alpin house.

Announcements/Reports/Presentations

1. Glen Alpin Conservancy. Presented \$37K check representing the balance of the \$47K that the Conservancy promised to raise to match state grant money to ensure that the Township would not have to find the matching funds.
2. Signs. Ned Ward said that he had received comments that there is a proliferation of permanent traffic signs (speed, stop, direction) – so many that are not in keeping with Harding's rural character. Ward counted 32 signs from Featherbed Lane to Spring Valley by way of Van Beuren Road.
3. John Murray and other Morris County advocates of affordable housing are to be honored at a breakfast on October 7.
4. A Waste Water Mgmt planning committee, consisting of Township employees has been appointed by Administrator Gail McKane to serve as

a contact point for Morris County relative to issues of sewer, septic and land use.

Correspondence

A group of residents delivered a letter to the Township Committee stating their position on Morris Township's revised proposal for the Mt. Kemble sports fields (Sept 3). The residents support the use of the parcel "as parkland" with the conditions that prior to rezoning and purchase (1) a deed restriction is completed on the adjacent 25 acre parcel; and (2) a memorandum of agreement is completed to ensure that the fields are grass; that there are no lights, PA system, bleachers, concession stands or alcohol; resolves which township is responsible for safety and patrol; that the park is for use by children, "to be developed once and done". During his Sept 3 presentation, Morris Township's Mayor Nace, of Morris Township, said that lights for night play were essential. Therefore the Township Committee has to make a decision between the desires of Harding residents and those of Morris Township officials. Harding Record Set – a record of 51.5 minutes was set for the shortest Regular Meeting!

Township Committee Regular Meeting – October 1, 2008

Attendees – Barlett, Lanzerottis, Murray, Rybka, Ward

Ordinance – Public Hearing. Ordinance amendment regarding public intoxication passed adhering to state law requirements.

Resolutions – various resolutions discussed and/or passed including:

- a. authorizing execution of Interlocal Service Agreements for the use of the County Mobile Data Terminal System and Radio Dispatching Services for 2009. Annual cost to Harding Township will decrease by \$1,003.00
- b. acceptance of generous donation to the Harding Township Police Department by Mr and Mrs Tungare.

Resolution deferred to future meeting regarding the authorization of executing a right-of-way agreement between the Township and Fiber Technologies Networks, LLC pending company's appearance before the Township Committee.

Announcements/Reports/Presentations

1. Mt. Kemble Recreation Facility. Committee confirmed the plans for a "balloon test" to take place at the facility on Saturday, October 4th pending appropriate weather conditions. Test is being conducted in an effort to help measure impact of lighting for proposed athletic fields. A resident of Harding spoke of his concern about the plan and that the Township

Committee continues to consider alternative proposals from Morris Township even though many residents are strongly opposed. The Committee clarified that at the September 3rd meeting it was agreed that Morris Township had adjusted the original proposal to address a number of the concerns voiced by both the Committee and Harding residents. Though no new resolution has been proposed or voted on, the Committee believed that one of the outstanding issues (lighting) needed further investigation as a next step. Morris Township was complimented for their efforts to work towards a mutually agreed upon solution. Another resident who spoke at the meeting asked how, if approved, would the specifics of the agreement be enforced in the years to come. The Committee stated that the Harding Township's Planning Board would provide the necessary oversight to all terms and conditions of any contract.

2. Historic Glen Alpin House. A closed meeting was held on Monday, Sept 28th with members from the Township Committee and Glen Alpin Steering Committee to discuss the status of the Request For Proposal (RFP) for the restoration and adaptive re-use of this Harding property. It was agreed that a major effort needed to be put forth by the Township Committee and all willing residents to actively market this location to potential tenants. As a result, the Executive Committee has approved the RFP which will be released and made available on the town's website within one week's time. Because of the sources that have provided significant grants for both recent and future restoration, only a singular or multiple non-profit organizations would be eligible to lease this nine and three quarter acre property and historic building. The town is anxious to find a suitable tenant and as a result, notable efforts will be made to market the RFP.
3. Ten Towns. Members of the Township Committee and the Harding Township Environmental Commission met recently to discuss Harding's participation in Ten Towns. It was determined that further information was needed in order to better understand both the current viability as well as future direction and goals of this initiative. The group agreed that subcommittees needed to be immediately formed to review many areas of question including the general financial structure, use and management of grants, specific projects and benefits and partnerships. It was stated that Harding Township contributes \$12,900 annually which represents

more than 50% of the combined participating towns' fees. The fees are set based on proportion of land mass.

4. New Parking Lot at Town Hall. Resident commented on how attractive the new parking lot is and that the new lighting is particularly helpful.

Board of Adjustment, September 18, 2008

Resolutions – Approved

Harding Property LLC (Part 2), 55 Red Gate Road, Block 6 Lot 2.01 Zone R1, as amended; granted a 62' setback for an emergency generator.

Johanna Geraghty, 79 Primrose Trail, Block 40 Lot 7.01 Zone R-4; permitting an addition resulting in a building area ration of 20.5% and rear setback of 18.2'

Pending Application

Daniel and Samantha Anderson, 613 Van Beuren Road, Block 5 Lot 7.09 Zone RR, "C" VarianceA site inspection was conducted. A revised plan was submitted reducing impervious coverage, making it compliant. Three variances remain, lot coverage, setback and height. Again, there were several comments from the public against the granting of variances. The Board stated that they may consider approval of the application if proper landscaping is proposed. The application was adjourned until the next meeting and a revised landscaping plan will be submitted.

New Applications

Tallaksen Construction (Contract Purchaser), N.J. Audubon Society (Owner), 137 Lee's Hill Road, Block 51, Lot 8, Zone RR

A variance is needed because the lot is 3 acres in a 5 acre zone. In addition, variances are needed for side setbacks. The existing home will be knocked down and the current septic system will remain. The lot is very wooded and an attempt will be made to maintain as many trees as possible. The lot has grading issues which effect the location of the new home on the lot. A site inspection was scheduled for September 27, 2008, at 9:00 am. Formal action may be taken by the Board at the site inspection. Public comment was generally in support of the project.

Board of Education/School News

BOARD OF EDUCATION – SEPTEMBER 8, 2008 Meeting: Present were Evelyn Douglas, Regina Egea, James Novotny, Jane Connell, new Superintendent Dr. Timothy Purnell and Edward Pladdys. The main agenda item was a progress report of the Academic Intervention Program (AIP), which offers supplementary individualized instruction for students experiencing academic difficulties. Fraida Yvalberg, Interim Supervisor of Student Services, described how, in July 2008, the state Board of Education increased the required scores on math and reading proficiency tests for 5th -8th grades. Consequently, proficiency levels at Harding from 2008 cannot be accurately compared to those from 2007; as a result, it is hard to determine whether AIP has lead to either an increase or decrease in scores. However, Ms. Yvalberg did suggest improvements to AIP. Harding did not hire additional staff for the program, AIP remediation is only 40 minutes a week often with a non-subject teacher, and parents are permitted to opt-out of the program. Ms. Yvalberg suggested that students with scores of 210 or less should be encouraged to participate in AIP voluntarily, and that students with scores below 200 should be required to participate. In addition, she suggested that AIP take place twice, not once, a week, and that the school consider hiring additional staffing trained in the requisite content areas. Ms. Douglas expressed concern about spending more money on AIP when the Board has no proof whether AIP is successful. The Board referred the issue to the Curriculum Committee to recommend a course of action.
