Finishing touches are being made, the book shelves and furniture are in place, and final inspections are winding down. When we receive the go-ahead, the Library will have to close its doors for a week while we transition from old quarters to new. Two Eagle Scouts have made it their projects to plan, oversee, and carry out the moves of the children’s and adult materials. We are delighted to have their enthusiastic help—and that of their crews! Sneak Peak at the New Library

The Thumbnail was recently treated to a tour of the new Kemmerer Library...OUR new Library. Even unfinished, it looked inviting—the word cozy immediately springs to mind. It clearly will be a great asset to the community.

Entering through the main door, a visitor is in a foyer, future site of a donor wall, still in the design phase. (There's still time to get your name up there if you hurry!) On this main floor is the largest room that comprises the circulation desk, Director's office, teen section, computer banks, tables, easy chairs, and book stacks. To the right is a children's room graced with lots of light and air, bookshelves, and kid-sized furniture, and computer stations. On the opposite side of the main floor is the adult reading room—a home-like space with gas fireplace, a lovely bay window facing Bayne Park, more stacks, racks for periodicals, glass display cabinets, and comfortable seating.

The lower level has one large multi-purpose room with capacity for 85 people. A second meeting room, which can accommodate 72, sports a big pull-down screen for presentations, large tables with stacking chairs, and wireless access. There is also a "lounge" for small group meetings and study sessions. Because of the topography, there is walk-out access to the outdoors, so no danger of "basement feeling."

The upper floor is for staff, storage, processing new arrivals and packing inter-library loan books, archives, IT room, shelving for seasonal materials, offices, and a small conference room for Board meetings.

In style and materials, the exterior aesthetics complement Kirby Hall nicely. The New Vernon Garden Club has generously prepared a landscaping plan and agreed to plant and maintain it for the next few years.

Although the Township has leased the land to the Library for a nominal annual fee, virtually all funds came from private donors: to date, just a tad under \$6 million. Fundraising is now focused on creating an endowment of about \$3 million to cover operating expenses into the future. So the Library, like our Fire Department and First Aid Squad, was built and will run without benefit of tax dollars, fueled solely by the generosity, hard work, and civic mindedness of donors and volunteers. **Donations for the Library can be made to "Enriching Our Community," PO Box 283, New Vernon, NJ 07976-0283.**

Harding Township Police Department and Morris County Communications expands Emergency Notification for Public Communications during Emergencies

The Harding Township Police Department wants residents to be aware that the county emergency communicator is now ready to accept cell phones for emergency messaging. Utilized by public safety agencies across the county, the Emergency Notification System swiftly and accurately alerts personnel and communities-at-risk during emergencies and other time and safety sensitive events. The System provides quick and easy selection of targeted geographic areas requiring rapid, accurate communication. The seamless integration of digital, street-level maps with the most accurate phone data available enables the immediate delivery of incident-specific information or potentially life-saving instructions. Whether alerting local residents of a fast approaching storm front, a missing person or mandatory evacuation, the technology quickly distributes important, timely information to everyone inside user-defined call-out areas.

The Morris County Emergency Notification System has been in use since 2004, utilizing landline telephone listings. As of today, residents can now register their cellular phones for notifications tied to their address. By logging into the website, <https://morriscounty.onthealert.com/>, they can sign up to receive emergency notifications based upon their home or business location in Morris County. In the event of an emergency in the area, an "EMERGENCY ALERT" phone call may be initiated by your local police or emergency management department, which will continue to call wired, location specific phones as well as up to three cellular phone numbers per location for those who have registered. WILDLIFE MANAGEMENT COMMITTEE

In its efforts to control the Canada geese population in Harding Township, the Wildlife Management Committee is asking residents to help identify locations where Canada geese might be nesting in the Township. Volunteers are ready to assist by treating eggs so that they will not hatch (called addling), using methods approved by the Fish & Wildlife Service.

If you have a body of water on or near your property, or have seen goslings in prior years, it is likely that you will have nests again this year. Harassing birds during the nesting season, or removing eggs from nests is counter productive, because it will encourage the birds to re-nest out of sight, where eggs can't be found or effectively treated.

Early identification of bird pairs and nesting sites does much to assure the process. Migratory geese will leave the area by the end of March. Resident bird pairs will then be more visible, usually claiming an area and keeping other pairs away. If you think your property is a potential nesting site, if you see obvious pairs, would like to learn more about what to look for or to help in spotting or treating nests, please contact the Committee at khmeister3@aol.com, (973) 605 8274 or r.a.shields@att.net, (973) 906-8357.) A property conducive to nesting should be monitored weekly throughout the nesting season, which starts in late March and ends mid May. For help and best results, please call us sooner rather than later. Addling eggs controls the growth of the goose population. Done properly, it is both, humane and effective!

HARDING HUMANE SOLUTIONS

Harding Humane Solutions urges residents to take the simple steps necessary to reduce the likelihood of conflicts with wildlife. Key among these is not to feed wildlife, intentionally or unintentionally. Casually storing untreated, unsecured food garbage outside near your home or on screened porches invites trouble. Please always store garbage in tightly sealed containers and put cans out just before collection, not the night before. Tamper resistant containers are available. Spilled bird seed or easily accessible feeders invite everything from rats and mice to black bears to come for a visit. Especially now through Fall, when bears are most active, birds can get along fine without supplemental feeding. (Seed now on hand can be donated to the Raptor Trust!) Even when our intention is to draw "just small animals" to a site, their larger predators inevitably follow. A dirty barbecue grill invites bears and others to your home.

The impact of any of these visits on humans ranges from mere nuisance to a traumatic encounter. With a little effort, both can be avoided. Bottom line is whenever wildlife is drawn closer to people, wildlife loses. For more information, email: hardinghumanesolutions@att.net

TOWNSHIP NEWS: Township Committee Meeting – no report this month

PLANNING BOARD MEETING- FEBRUARY 22, 2010

Roll Call: Marshall Bartlett and David Dietz absent.

Reports: Mrs. Olcott said that she will report back to the Board regarding the advisory Review Committee once an agenda is firmed up. Mr. Saulnier reported that the Build Out Committee will be digging into the country report, in particular the nitrate analysis. The Board confirmed that it still wanted to do an engineering training session for members.

Resolution: PB-01-10, **Applicant William and Richard Blanchard**, Block 26, Lots 13 and 13.01, 42 Glen Alpin Road, Amended Minor Subdivision. A revised resolution memorializing what was approved last month was approved.

Applications

PB-12-08, Applicant The Cutler Partnership, LP, Block 4, Lots 10 and 4, Red Gate Road, Minor Subdivision with Variances, Action: Extension on Board Approval. The applicant had been dealing with two obstacles. An issue with a shared drive had been resolved, but the DEP had not issued a wetlands approval. Extension approved.

PB-05-09, **Applicant Hartington J Trust**, Block 7, Lot 1.01, 1.02 and 4.02, Griffin Lane and Van Buren Road, Preliminary and Final Major Subdivision, Action: Continue Public Hearing. A site inspection was conducted on the property on February 13th. The applicant's engineer presented the plan and discussed several items including the improvement of Griffin Lane and the extension of the drive to the two new lots, shifting of the lot line between the Carey lots, transition area averaging plan clean up, and the shifting of the location of the cistern. The design of the driveways was extensively discussed, with the Board preferring "Plan B" where the left fork is eliminated and a new drive for Lot 4.02 off Griffin Lane is constructed. This would reduce impervious coverage. Mr. Fox reviewed his report which covered possible steep slope issues on Lot 1.02, wetlands and waterways, riparian buffers, the need for a flood hazard development permit, storm water management, use of an easement to connect two existing bridle paths, protecting the hedgerow between two of the lots, and the need for the Fire Department to review the revised plans. Public comment included concern about preservation of the tree line between the two new lots which can be covered with a conservation easement.

PB-02-10, **Applicant James and Dawn Didden**, Block 4, Lot 56, 12 Hartley Farms Road, Minor Site Plan, Action: Commence Public Hearing. The applicant was not represented at the meeting, but the board considered the completeness of the application. The Board waived the requirement for a Morris County Planning Board application, but did not waive Board of Health approval, showing historic districts on the plan, and showing existing Hartley Farms easements or covenants on the plan.

This application involves the expansion of an existing non-conforming structure. The front yard setback does not comply with the ordinance. The application was recommended for approval.
