### TOWNSHIP NEWS:

#### **Township Committee Meeting – October 18, 2011, All Committee persons attending** **Ordinances Introduced**

1. Small Back-up Generators Rules Eased. Planning Board presented an ordinance to eliminate the permitting process for generators less than 20 kw and using a pad less than 20 sq ft. The pads would not count toward total lot coverage and would be relieved of lot set back rules. Generator would have to be within 20 feet of the owner’s home and screening plants is encouraged.
2. Downtown Redevelopment. Amended the B-1 zoning of the “downtown New Vernon to encourage business growth.
3. Towing Service contract must be awarded via a bidding process or have a rotating list of contractors. This is for situations where the PD calls for towing (accidents, illegal

parking, etc) and conforms to a NJ State “Anti-Predatory Towing Service Act.” The PD call for about 100 tows per year. Citizens pay for the tow but this act protects the citizen from gouging by a towing company that might be favored by a police department.

**Bayne Park Stream Bank Restoration Project** – Great Swamp Water Shed Association proposed work on the banks of Bayne Park pond to restore the water to its natural chemistry that has been altered by road salt and “immeasurable” amounts of nitrogen and phosphorus. The plan calls for replacing invasive plant species with native grass and shrubs. To ensure that deer do not eat the plants before they can get established, a seven foot high fence in three areas is part of the plan. The \$2600 cost would be borne by a grant, not the Township, though maintenance costs would be the Township’s responsibility. The height of the fence was troubling, but ultimately accepted as necessary.

Committeeman Lanzerotti was very concerned by the absence of any scientifically valid data that would establish a baseline for the conditions and as well as lack of a follow-up plan to measure any improvement. His concern about the lack of data was such that he offered to donate \$600 per year for 5 years to cover the cost of the data gathering – “must do the project right”.

**Snow Removal Contract Let for The Farm at Harding.** Two bids were submitted and the contract was given to the low bidder from Wharton boro. -- \$795/application of salt and \$1200/plow. Maximum of \$5K for the balance of 2011.

There was discussion, initiated by Roberta Shields, speaking as a citizen rather than as a member of the Wildlife Mgmt Committee, regarding whether the Township Committee should **Urge the National Park Service to Implement a Deer Mgmt Plan.** Apparently the “understory” of the Park area (tree seedlings) is being stripped by deer thus setting up an ugly treeless future for the forests. Ms Shields asked why the TC would try to influence the Park Service with a letter or resolution, while it didn’t try to influence the Great Swamp Association to manage the goose population right here in Bayne Park. She said that she had not seen this proposal although she is an active member of the Wildlife Committee. Further she pointed out that deer “management” is not just culling. Lastly she asked if the comment and discussion period on deer control ended in August, why is this happening now? The answer was that Karl Meister, Chairman of the Wildlife Commission, urged the TC to make this request of the Park Service, although without apparently mentioning this to the rest of the Commission.

**Hired Replacement for Township Clerk.** After a process which included receipt of 20 resumes, 10 interviews and 2 call backs for second interviews a clerk was hired at a salary of \$38K, slightly below the compensation of the prior clerk.

### DISCUSSION TOPICS

**Finances for 2011 Tracking Well vs Budget.** Revenues are about 1% over budget while spending in almost all categories is at or below plan.

**2012 Budget – “Will Need to Make Harder Choices”.** Next year’s budget discussion will roll out as follows: Nov 16 – preliminary discussion of “key drivers”; Dec 21 – Proposed Budget unveiled; Jan 18 – Police and DPW budgets discussed (aside Police have one more year on their current contract). 2012 will be another difficult budget as ratable property base will decline slightly for the first time in memory due to new farm assessments and property tax appeals. A citizen asked how many houses have been built (but not occupied) or improved and have not been reassess upward? Questioner was assured that this will be investigated.

### **Cell Tower Advisory Committee – Church Site Recommended.**

Recommended the site on the property of the Seventh Day Adventist Church over the 3 alternatives (Glen Alpin, Harding Township site and DOT site). Concern was raised about the rigor of the analysis of all the sites. Ben Jean, whose property is on Tempe Wick Road said he was opposed to using either the Glen Alpin or Church sites.

**Library Volunteers To Be Recognized BY Governor** for Service During Hurricane Irene. Governor Christie asked all NJ municipalities to choose a group or individual for special recognition for their service during the hurricane. The TC chose the Library volunteers who opened the facility for comfort, water, charging and companionship during the disaster. Judie Ward, Alice Condon, and Elaine McHale of the Library operating committee attended and were recognized at the Trenton recognition ceremony.

**What is the Township’s Follow-up to Hurricane?** (Asked by resident Mike Meade.) In general Irene created what Mayor Bartlett called “an unacceptable failure of infrastructure”. Here’s what has been done so far: (1) Had first meeting with NY American Water. Osborne Pond needs a new spillway. (2) Contacted JCP&L which said they had a communication problem and that their Operating Center was not giving out accurate information. (3) Contacted Morris County – to little avail. (4) Created a 12 person Emergency Preparedness Committee to work this issue. (5) Have consultants

looking at how DPW can do a better job to restore power to key sites like the sewer pumping station that failed. (6) TC-persons Egea is drafting a report and (7) Lanzerotti is working with Harding School (8) PD has an emergency communication system in place that works over wireless (cell phone) system that citizens can tap into. The relevance of this effort was proven by the subsequent late-October snow storm which proved far more devastating for many residents.

**Privacy Concern Raised.** Resident Judy Malloy, for the second time, raised a concern about privacy caused by the new Construction Office streamlining procedures and the ombudsman role. Specifically, why does a committee person (Nic Platt and Ned Ward) need to read applications? TC-man Platt assured Ms Malloy that neither he nor Mr. Ward “have not looked at a single plan” though they are copied on applications in their role to monitor work flow to ensure timely movement of plans through the department. The “fact of an application” is public information, though the details of the application are not public. As background, Platt explained that the building department was a source of significant complaints by contractors and their clients as it sometimes took as long 2-3 months to get approvals. The process was examined and “best practices were developed and implemented. The construction department was made more efficient while a large portion of the delays were found to be due to incomplete applications by contractors. Now homeowners, contractors and the building department all know the status of applications so there can be no finger pointing. Platt reported that things are running smoothly and that he has not had to get involved in an issue for four months.

### **ENVIRONMENTAL COMMISSION, October 3, 2011**

### **BRIEFING ON HIGHLANDS PLANNING PROCESS**

David Peifer, Highlands Project Coordinator, ANJEC gave a presentation on the Highlands, pointing out that this was a mountain range which encompasses PA, NJ, NY and CT. He explained the conformance process and the benefits to municipalities. He further explained that conformance is mandatory in the conservation areas; however, it

is optional in the planning areas. There have been 65 conformance petitions submitted with 53 administratively completed. 30 of the 88 towns in the Highlands have already opted in. D. Pfeifer will send K. Meister additional information regarding the Highlands Planning Process.

### **LIAISON REPORTS**

**Planning Board (PB)** – P. Saulnier stated that the PB met on September 26, 2011 and has been updated on the activities of the EC. He stated that there is a meeting scheduled for October 5, 2011 which he will attend concerning the ownership and maintenance of Bridle Trail Easements. He also reported that the Planning Board was in favor of fast-tracking applications for the installation of emergency auxiliary generators. P. Saulnier will draft a comment concerning the generators on behalf of the EC, pertaining to the enforcement of the setback rules, bearing in mind the emergency needs of the community.

**Board of Adjustment (BOA)** – H. Symonds reported that the BOA met on September 15, 2011 and has been updated on the activities of the EC. He reported on an application for a setback variance for the Merlin Property located at 15 Brook Drive North, wherein a variance was requested for a lot setback to install a swimming pool within 25 feet of their back lot line. An alternative location was not feasible due to easement restrictions. A site inspection was performed. It is the recommendation of the EC that the setback variance not be granted as it does not conform to the existing setback rules and the owners were aware of the consequences when they agreed to the easement restrictions.

**Citizen's Park Advisory Committee (CPAC)** – J. Kovacs reported that the CPAC was offered a grant through the Great Swamp Watershed Association in the amount of \$3,000 for the replanting of warm season grasses and shrubs at Bayne Park Pond. J. Kovacs stated that after much discussion it was decided that CPAC would make the recommendation to the TC to accept the grant. The EC supports the acceptance of the grant from the Great Swamp Watershed Association, because it will filter the runoff from the surrounding slope as it enters Bayne Park Pond.

The EC also advocates the installation of a swale replacing the present direct outlet of storm water from Millbrook Road to the creek below Bayne Park Pond.

**Harding Open Space Trust (HOST)** – J. Kovacs reported that plans for the Lohuis Property have been resubmitted. The plans detail a 45 foot long barn that will run

parallel to James Street with a height reduction from 23 feet to 20 feet. It was discussed that these plans are at variance with current setback rules and should therefore not be approved. This will be conveyed to the BOA. It will also be conveyed that the EC maintains that setback rules in general should be given strong support and enforcement.

**Shade Tree** - No report

### **PROJECTS**

**Easement Stewardship** – Easement Consultant, Harriet Honigfeld gave an update on the Easement Stewardship Project. The form for establishing the baseline on an easement was modified, to better coordinate with the easement inventory spreadsheet and make it more effective for municipal level reporting. The form will be available on the Civic Association website. K. Meister provided the easement inventory information to Steven Balog, Civic Association reporter for the TC. H. Honigfeld also suggested utilizing several computer websites for uploading easements to facilitate monitoring and easement stewardship. The inventory process has been completed and the EC will now organize a pilot inspection of a Priority One Easement, to organize the monitoring process in general. It was suggested to start with the Thebault Property. J. Kovacs will spearhead the monitoring process. K. Meister will follow-up with C. Allyn to update the computer system with regard to easement monitoring.

**Lighting Ordinance** – J. Morgan presented a revised draft of the basics of an Ordinance. A discussion ensued resulting in a recommendation to define and quantify terms with regard to frequency and duration of illumination and light candle limitations. J. Morgan will make the revisions to the draft. It was approved by a majority vote of the EC to submit the draft to the PB.

**Deer Fencing and Ostentatious Gates** – R. Clew presented a draft of the EC's recommendations on a Deer Fencing Ordinance. A copy is attached. The draft was accepted as presented and it was decided to submit it to the PB for further consideration. With regard to the subject of Ostentatious Gates, the EC decided that this is not within the purview of the EC.

**Energy Efficiency Analysis** - The EC proposal to de-activate a number of streetlights in the township, was reviewed and accepted in principle by the TC. An article describing the plan and its rationale will be published on the Civic Association website and in the Thumbnail, to apprise the residents of the project. The TC requested the numbers of

each of the light poles, which are to be de-activated. H. Symonds has agreed to provide this information.

**Second Clean-Up Day** - R. Clew reported that there was a good turn out for the first Fall Roadside Cleanup with at least 20 volunteers. The EC congratulated R Clew on a job well done. He in turn offered special thanks to E. Wiener and K. Meister for helping to get the word out; L. Lanzerotti for running the dispatch center from the Townhall parking lot, and T. Toribio for providing all the bags, vests, gloves and tee shirts for the volunteers participating in the cleanup.

### **NEW BUSINESS**

**Updates** - K. Meister reported that he had a meeting with Mayor Marshall Bartlett on September 26, 2011 wherein a draft of the minutes of the September 12, 2011 Environmental Commission were discussed. Regarding Easement Stewardship, M. Bartlett was in agreement with the implementation of a pilot program. Regarding the Lighting Ordinance, M. Bartlett was in agreement with A. Newlin in that the current lighting ordinance is basically sound but could be amended to consider foot candle limits and bright entrance lights that could pose a potential traffic safety hazard. Regarding Deer Fencing and Ostentatious Gates, M. Bartlett was in agreement with the EC recommendations to increase the setback to 50 feet from the centerline of the road and that similar side and rear setbacks should also be reviewed taking into consideration the size and shape of the lots.

**EC Vacancies** - K. Meister called to the Commission's attention that there were two vacancies on the EC and that these positions could serve as alternates. The EC consists of seven regular members and two alternates. The alternates would participate in meetings but would not vote, unless they were sitting in for a regular member who could not attend. It was recommended that the EC review candidates for the alternate positions for further discussion at the November 7, 2011 meeting.

**Continuing Education** - K. Meister distributed to the members two Resource Papers published by ANJEC, the Association of NJ Environmental Commissions: "Municipal Environmental Commissions in New Jersey" and "Site Plan/Subdivision Review: - Environmental Analysis". K. Meister also recommended that the EC purchase reprints of two more recent ANJEC Resource Papers: "Municipal Options for Stormwater Management" and "Open Space Plan" The copies are 50 cents each plus postage. D. Hicks will make arrangements to obtain copies for the EC members.

**Downtown Committee** - K. Meister shared an email he received from Tom MacCowatt dated October 2, 2011 with regard to the Sustainable Jersey program for the Downtown Committee and that they were seeking input from the Environmental Commission. K. Meister explained that the Downtown Committee is involved with the revitalization of the downtown area of New Vernon. He reviewed a memorandum, dated 7/12/11 from members of the Downtown Committee, outlining revisions to pertinent existing Ordinances. P. Saulnier, who also serves on the Downtown Committee, offered to email the EC members a copy of the pertinent documents for review. K. Meister suggested that the EC members review the drafted Ordinance and submit their comments to him by October 8, 2011.
