#### **WILDLIFE MANAGEMENT COMMITTEE**

This group invites you to attend either of two showings of the one-hour film "living with NJ Black Bears, Friday March 16 at noon or Thursday March 22 at 5PM in the Harding Twp Kirby Municipal Building main meeting room.

In its efforts to control the Canada geese population in Harding Township, the Wildlife Management Committee is asking residents to help identify locations where Canada geese might be nesting in the Township. Volunteers are ready to assist by treating eggs so that they will not hatch (called addling), using methods approved by the Fish & Wildlife Service. If you have a body of water on or near your property, or have seen goslings in prior years, it is likely that you will have nests again this year. Harassing birds during the nesting season, or removing eggs from nests is counter productive, because it will encourage the birds to re-nest out of sight, where eggs can't be found or effectively treated. Early identification of bird pairs and nesting sites does much to assure the process. Migratory geese will leave the area by the end of March. Resident bird pairs will then be more visible, usually claiming an area and keeping other pairs away. If you think your property is a potential nesting site, if you see obvious pairs, would like to learn more about what to look for or need help in spotting or treating nests, please contact the Committee

For help and best results, please call us sooner rather than later. Adding eggs controls the growth of the goose population. Done properly, it is both, humane and effective!

### **Health Screenings:**

### **Dog Licenses:**

If you reside in Harding Township and own a dog, age 7 months and older, that dog or dogs must be licensed every year by January 31, 2012. Harding Township gives their residents till February 29, 2012, after that date a late fee of \$10 per dog will be charged. ### **National Public Health Week**

National Public Health Week is April 2-8, 2012. A healthier America begins with strong public health systems across the country. With nearly 1 million Americans dying every year from diseases that could be prevented, even small preventive changes and community initiatives can make a big difference in living healthier lives. The focus of local public health department interventions is to improve health and quality of life through the prevention and treatment of diseases and other physical and mental health conditions.

Local health departments educate the community regarding health and environment issues and enforce laws and regulations that protect health. Healthy behaviors and disease prevention are encouraged by offering immunizations and clinics such as cancer screening, adult bloodwork screening and rabies vaccinations for animals. Investigating health problems and linking people to the health services they require is another community service.

During Public Health Week visit the Harding Health Department on the second floor of the Municipal Building. Meet your health department staff and pick up a packet of educational material.

### **Harding Township School's Husky Pups**

The Harding Township School is accepting registrations for the "Husky Pups" pre-school program for the 2012 – 2013 school year. The program is open to children who are three or four years old. Instruction is differentiated between the three and four year old children within the classroom to cater to their development. The "Husky Pups" pre-schoolers will attend the program five days a week, for two hours and forty-five minutes each day. There are two sessions, with the morning program running from 8:25 – 11:15, and the afternoon program running from 12:10 – 3:00. Tuition is \$3,650 to be paid in monthly installments.

The program is taught by a certified teacher with a primary school endorsement. Teaching assistants also provide support for the class. The program offers a multi-sensory, interdisciplinary curriculum that reaches all students. In the past the "Husky Pups" have enjoyed exciting experiences throughout the year, including a visit from the New Vernon Volunteer Fire Department, a field trip to the Crewe Hill Horse Stables, hatching chicks in the classroom, and cooking lessons!

## **TOWNSHIP NEWS:**

### **TOWNSHIP COMMITTEE MEETING – February 21**

Attending: Bartlett, Lanzerotti, Platt, Ward

Alf Newlin, the current head of the Planning Board, was sworn in to replace the seat vacated when Regina Egea resigned. The meeting was standing room only as citizens turned out to voice their views about rumored actions on the Police Department.

But first the, TC again updated the community on the status of the 2012 operating budget and also unveiled the preliminary capital budget. The operating budget is still showing a \$230K deficit that will be closed by further tax increases and or cost cuts. The budget includes 4.1% salary increase for the police (contractual for this the 4<sup>th</sup> year of the contract), a 2% salary increase for the police chief and other employees. The budget fully funds health care and pension costs and it absorbs the approximately 1% reduction in the

assessed value of properties. The budget discussion and process will continue into March when the budget will be formally introduced and April when the budget will be adopted.

A review of HT debt showed that: (1) the 1992 Green Acres loan has been paid off, (2) the 2001 \$1.7 bond issue will be paid off in 2016 and (3) leaving the balance of \$7.7 million (2008 issue) which funded \$2.9mm of Open Space and \$4.8mm of low income housing project (The Farm at Harding) at Kitchell Road and Woodland Avenue. Aside: 50% of your Open Space property tax goes to paying principal and interest.

The Capital Budget for 2012 is \$340.5K. Details can be found on the HT website. Large categories are improvements and repairs to facilities (\$108K), upgrade for Police Dept info technology (\$14.5K), redevelopment zone (\$95K), The Farm at Harding (\$25K), design of two more units at The Farm (\$25K), basins (\$70K) and DPW equipment (\$3K). All of the capital items are paid on a cash basis and are not financed with borrowing.

The citizens then had a chance to talk about the police force. The concern seems to be that the TC is considering merging the Harding Police Department with another town ("shared services") and that the comments from the audience were nearly unanimous in their support of the police department and included recollections of a number of positive actions. The meeting got a bit heated at times with an accusation that a cover story in the Observer Tribune (which highlighted the HT PD's high cost but HT's low crime rate) was "orchestrated" by the TC (flatly denied). One citizen went so far as to accuse the TC "that they had already decided" to consolidate the PD and he gave as evidenced by the "scowls on [your] faces" at which point the individual stormed out of the room. Your reporter, an observer of the TC of many years, did not see any scowls.

With some exasperation, Mayor Bartlett assured the crowd that "of course!!!" the public will be able to participate in discussions about important actions regarding public safety. He said that "public perception is way ahead of reality" and that nobody on the TC wants to jeopardize public safety" and he emphasized that "short response time is important".

TC member Nic Platt said that the whole issue about the police came up in January because in ticking off all the issues facing the Township for 2012 the PBA contract negotiation is a big one. He said that "every single department will be looked at for cost savings" – DPW staffing has been cut back in prior years as has their work schedule; The construction department, with much higher fees now runs at breakeven; and flu shot are now charged for whereas in the past they were free. He said that the Police Department is now requires some "creative solutions".

Interestingly, even some of the most vociferous supporters said that they were "not against studying the Police Department, even shared services" and that "nobody is saying that consolidating is the wrong way to go". But these individuals said that the discussion should be done in the open with input from the Chief and the public. Rounding out the

discussion, two citizens said that there was “too much tension” and vitriol and that her fellow citizens should “hit the subject, not the people”, meaning our (unpaid) TC members who are responsible to take all the needs of the community in total and ask the citizens to fund it with their property taxes. At this point, with the excitement over and people having had a chance to air their views, the room mostly emptied as the TC got back to the usual mundane business – paying bills, transferring funds and making appointments.

However, perhaps the crowd should have stayed as the TC considered a change in the PBA’s HC plan that they said would save taxpayers \$89K annually (about \$67K for the balance of 2012) while not changing the benefits or impacting the 8 officers’ pocket books. The PBA union representative was in the audience and voiced the union’s objection to the change saying that this change should be part of the overall contract negotiations later in 2012. The TC passed the resolution.

### **PLANNING BOARD MEETING January 23, 2012**

Mr. Hall, as temporary Chair of the Planning Board, called the meeting to order. He announced that Mr. Bartlett had been reappointed as a Class I member, Ms. Egea as a Class III member, Ms. Olcott as a Class IV member and Ms. Ditosto as a Class II alternate. He also stated that all members of the Board had signed the oath of office.

Roll Call: Mr. de Poortere and Mr. Edgar absent.

#### 2012 Reorganization Meeting

1. Mr. Newlin was then re-elected Chair of the Board, and Ms. Olcott was re-elected Vice Chair.
2. A resolution to provide professional services was approved.
3. A resolution approving meeting dates for 2012 was approved.
4. A resolution appointing the Board Secretary was approved.
5. Swearing of professionals was deferred to the next meeting since the planner and the engineer were absent.

Mr. Newlin then congratulated the Board members for their work last year, and expressed appreciation for Mr. Fox’s work for the Board.

#### Announcements/Reports/Presentations

The application of GHK Realty II/Fawn Hill Farm, PB-04-10 was carried to the meeting of February 27, 2012.

Mr. Newlin announced that he would like to set up a workshop with the Board to discuss water issues. Ms. Phillips reported that financial disclosure forms would be coming out soon, and that the Master Plan had been posted to the township website.

Mr. Schliefer reported that the Board of Adjustment was dealing with generators, constrained lots, and flag lots, and that the Hurstmont application had been deferred to the Health Department. There was some discussion as to why the Hurstmont application was

before the Board of Adjustment. Mr. Hall explained that the requested use variance (to convert the main building to town houses) and the density variance (to subdivide the property to create six lots and get ten dwelling units on less than 20 acres in an RR zone) were within the jurisdiction of the Board of Adjustment. There was some discussion about the role of the Planning Board in determining the fate of the property, and whether the Planning Board should be advising the Board of Adjustment. PB should be advising BA. Mr. Bartlett said he would call Mr. Rosenbach to see if he wanted input from the Planning Board regarding impact to the Master Plan. Mr. Saulnier reported that the Environmental Commission had met to hear John Murray speak about the easement monitoring project which included ranking the importance of the easements and recordkeeping.

Ms. Egea, reporting for the Township Committee, said that there were budget pressures resulting from lower construction activity, fewer moving violations and a decrease in taxes. Ratables are down 1%, and expenses are growing at 2-3%. The town departments are working on their budgets, and there will be a special meeting on January 26. There could be a possible re-assessment of property values in 2013 with changes implemented in 2014. Ms. Olcott reported that the Advisory Review Committee met in December to discuss the lighting ordinance. She said the Committee was asked to look at the tree preservation ordinance in relation to utility lines, and that rules regarding historic structures would be examined.

Ms. DiTosto reported that the cell tower application was going before the zoning board and that AT&T would be joining the application. She also reported that the Township Committee sent a letter asking that the DOT site be selected as the site for the tower.

#### Applications

PB-10-08, Applicant **Primrose Partners, LLC**, Block 46, Lots 6, 7.01, 8.03 and 10.04, Brook Drive South, Preliminary and Final Major Subdivision. Action: Amendment of Approval Condition. An amendment was approved extending the deadline for the placement of conservation easement monument to the end of this year.

#### Discussion

The Board discussed the appropriateness of letter of support for the Great Swamp Watershed Association Green Acres grant application for Primrose Farm. Mr. Newlin was not in favor of the Board taking a position and Mr. Hall advised that it was not necessary. The Board agreed that Mr. Hall would write a letter saying the application was consistent with the Master Plan.

The Board discussed the Environmental Commission Report on Outdoor Lighting Regulation. Mr. Saulnier reported that the EC agreed to look at the current ordinance and offer a proposal for changes. Ms. Olcott said she didn't see an improvement over the current ordinance which deals with nuisances. It was generally agreed that one big issue was enforcement of any ordinance. The Board agreed that discussion would be tabled pending



further data. Mr. Bartlett said that he would take up the issue of enforcement with Ms. McKane.
