**Bayne Park volunteers** are asking if you can join them in the effort to humanely ***control the Canada Geese population*** at Bayne Park this summer. **Just sign up to be "on call", at 10AM or 2PM, on any day from May 15<sup>th</sup> thru July 4<sup>th</sup>.** We'll call you minutes before your selected time slot & tell you if geese are present at the park. If so, you will come to the park to join 2 or 3 others to chase the geese away. It will take no more than ½ hour of your time. You will be using proven techniques, under the guidance of a trained volunteer. The birds learn quickly, and after the 1<sup>st</sup> few weeks, they rarely return.

Modest physical effort is required; primarily, the ability to walk across the park at a reasonable pace. All equipment is supplied. Shoes that can get muddy & long pants are suggested. This Township approved effort, so successful the last 4 years, was featured in "Goose Tracks 2008", a nationwide publication of the Humane Society of the US and in the magazine of the NJ League of Municipalities. ## **WILDLIFE MANAGEMENT COMMITTEE REPORT**

The following list was prepared in collaboration with members of the New Vernon Garden Club and reflects the experience of gardening in Harding. Residents might find it helpful in planning their spring plantings. Deer in our area rarely damage the plants listed. Nevertheless, they will browse at any plant, if no alternative food is available; also, each deer herd is different. The young deer eat what their mothers eat, and eating habits may vary from herd to herd. Deer will usually not eat any leaf that is gray and/or furry; many herbs fall in this category. **TOWNSHIP NEWS:**  
**TOWNSHIP COMMITTEE**

(From the Observer-Tribune):

With the June 5 GOP primary right around the corner, Republican Mayor Marshall Bartlett has opted to call it quits. When petitions were due in Township Administrator Gail McKane's office at 4 p.m. Monday April 2, Bartlett did not submit one. There are two, three-year seats up for re-election on the Township Committee, and one, two-year unexpired term. Bartlett said his six-year run on the committee has been enough. "I've enjoyed it, but it takes a tremendous amount of time. I'd like to free up some of my time to do something else," he said. The Youngs Road resident said he is still teaching at Fairleigh Dickinson University, and said he'd like to spend some time traveling with his wife. A first-time Republican candidate, Nanette DiTosto, is seeking Bartlett's three-year term.

Long-time Committeeman Ned Ward, also a Republican, will seek his third, three-year term on the committee. Ward, a realtor, lives on Tempe Wick Road.

Republican Alf Newlin, who was appointed to the committee earlier this year to fill the unexpired term of Regina Egea, will seek GOP voters' support to fill Egea's seat for the next two years. Newlin was formerly the chairman of the Planning Board before he was appointed by the Committee to fill Egea's unexpired term.

No Democrats filed to run. Retired Harding police officer Michael Meade has said, however, that he will run in November as an independent for a seat on the Township Committee. Meade attends committee meetings regularly, and often questions decisions made by the governing body.

**PLANNING BOARD MEETING, March 26, 2012**

**Declaration of Appointments by the Township Committee**

The meeting was opened by Mr. Hall in the absence of a Chairman, Mr. Newlin having been appointed to the Township Committee. Mr. Hall announced that the Township Committee had appointed Mr. Newlin a Class III member, Mr. Saulnier and Mr. Schliefer Class II members, and Ms. Ditosto as First Alternate.

Roll Call: Ms. Olcott and Ms. Moriarty absent.

Mr. Saulnier was then elected Chairman of the Board.

Announcements/Reports/Presentations

- Mr. Saulnier thanked Mr. Newlin for his service as Chairman, and said he hoped to continue certain practices such as training for the Board and annual review of professionals.
- Mr. Saulnier announced that there would be a training for the Board on “all things water” on April 14<sup>th</sup> at 9am.
- Mr. Saulnier said there might be some changes in subcommittee assignments after he has a chance to talk to people about current assignments.
- Subcommittee updates
  - Water and Environmental: Mr. Saulnier said the group was still working on the 25-foot setback from conservation easements.
- Liaison reports
  - Environmental Commission: Mr. Saulnier said the committee met on March 8<sup>th</sup>, and set April 21<sup>st</sup> as clean-up day in Harding, with a view to extending to a week to coincide with Earth Week. There will also be an easement stewardship training session on April 28<sup>th</sup>. The Commission discussed a proposal to remove street lighting, and is waiting on a risk management analysis. Nic Platt met with Chief Gaffney and JCPL to discuss street lighting. Other towns have done it with no liability. JCPL could go street by street to remove bulbs or reduce wattage. Mr. Saulnier also reported that the number of easements to be monitored had been whittled down to the 70's. The Commission was also wondering whether they should do more work on deer fencing, and was looking for direction on the matter.
  - Cell Tower Committee: Ms. Ditosto reported the Zoning Board was meeting on March 29<sup>th</sup> when the tower application would be heard for the first time from two carriers.
  - Mr. Bartlett reported that he had met with NJ Transit who is studying parking. He reiterated that we don't want a park and ride in Harding, but are interested in joint parking in Convent or Madison.

#### Resolutions

PB-03-10, **Applicant Blanchard Partners LP**, Block 49, Lot 12, 55 Glen Alpin Road, Modification of Approval Conditions for Preliminary and Final Major Subdivision. The original resolution called for bonding of all improvements; applicant wanted change to require building permit to construct, rather than putting up bonds when construction won't proceed in near future. Approved as written.



PB-01-09, **Applicant 151 Madison Avenue Corp./Hudacek**, Block 4, Lot 14, 610 Van Buren Road, Request for Extension of Time to Install Improvements. Applicant asked for an extension to install a road; everything is bonded. Approved as written.

Applications

PB-05-09, **Applicant Hartington J Trust**, Block 7, Lots 1.01, 1.02, 1.03 and 4.02, Van Buren Road, Preliminary and Final Major Subdivision. Action: Modification of Approval Conditions. Applicant is in the process of perfecting the subdivision and is requesting two changes. First, since the two lots in the rear are not likely to be developed, the applicant is requesting that the bonding be removed for the common drive to the lots, and put a restriction in the deeds that bonding would be required when building applications are submitted. Second, applicant is requesting that the wording for the bridle path easements be change to indicate that they are given voluntarily to avoid issues with the IRS. Oral resolution covering both requests approved.

PB-04-10, **Applicant GHK Realty II/Fawn Hill Farm**, Block 4, Lots 21 and 21.01, 655-665 Spring Valley Road, Preliminary and Final Major Subdivision. Action: Continue Public Hearing. There were several outstanding issues regarding the application including protecting the forest in the back lot, use of the driveway serving the farmhouse, and tree conservation along Spring Valley Road. The applicant's attorney reported resolution of several items after extensive discussion with the applicant, including:

- Creation of a forest preservation area in the back lot
- Withdrawal of the variance application for the pool house (eliminating the need for all variance relief)
- Leave farm lot drive as proposed, and not combine with new access
- Agreement with Bridle Trail Association on access to the property using a revocable license, and
- Creation of a 50-foot tree preservation area along Spring Valley, while preserving larger trees outside of the area

The Board authorized Mr. Hall to draft a resolution to approve the application with all conditions for consideration at the next meeting.

Meeting adjourned.

**HARDING SCHOOL BOARD**

In January, state legislators proposed and Governor Christie signed into law (A-4394/S3148), which provided municipalities and boards of education an opportunity to move the April Board of Education elections to November, where they would coincide with the general election. Last month, the Harding Township Board of Education voted to move the April election to November, effective immediately.

Under this new law, school budgets that fall within the 2% property tax cap would not have to be voted on by the community. School districts would still be required to submit its budget to the Executive County Superintendent in March and hold an annual public hearing later that month. Lastly, the public would vote for individual board of education members at the November election.

The 2012-2013 HTS budget is both student-centered and sustainable. It embodies, in spirit and in fiscal reality, the budget guidelines previously developed and approved by the Board of Education. The increase to the tax levy is only 1.78%, below the state mandated cap of 2%. Moreover, this budget protects all educational and co-curricular programs and staffing - one of our stated goals. Since our budget is less than the cap, our school budget will not be submitted to the voters.
