The HARDING TOWNSHIP COMMITTEE announced that the annual curbside clean-up will commence on Monday October 1st. Materials that will not be collected are building material, garbage, stones, concrete, soil, brush, yard debris, toxic chemicals, propane bottles and tanks, 55 gallon drums (empty or full), oil tanks and oil based paints. Lawnmowers and other gasoline-powered equipment must have the gas and oil drained. Hot water heaters and water conditioners must be drained. Pipes and single pieces of lumber must be cut or bent into sections four (4) feet or less in length. Latex paints must be opened and completely dried out. Please do not leave items in front of property sooner than ten (10) days before the collection date. Materials that will not be collected, but are acceptable at the recycling center are: all standard recyclables: newspaper, cardboard, glass, aluminum, plastics), barbeque size propane tanks, tires, computers and related electronic devices. Harding Township acquired lot 4.04, the corner lot on Sand Spring Lane for \$1,250,000, with township open space funds. In addition, six new easements on the Frelinghuysen property were recorded with Morris County in favor of the Harding Land Trust. The Land Trust also has signed contracts to purchase lots 19 and Lot 4.03, which we hope will eventually be funded by Morris County. TOWNSHIP NEWS:

Township Committee Proceedings Over the Summer - Police Department

As we have reported before the Police Department is a big topic of analysis and public discussion because the employment contract between the police union (PBA and the Township, which covered three years, ends and comes up for negotiation at the end of 2012. The TC promised a thorough study of the issues and the results of that work were reported at summer TC meetings.

To gather input from the Harding community at large, 25-30 meeting were held with interested groups (first aid and fire departments, Board of Ed, seniors, Great Swamp) and individual citizens. The first aid squads and the fire departments said the police are always the first on the scene they had good relationship with the PD. They suggested that all officers get EMT training, only one officer currently has it.

The Board of Ed said the police provide traffic control on Lee's Hill Road in the morning and afternoon but are not always able to do that and suggested that perhaps the school district can get a flashing light to control the traffic. The Great Swamp authorities said that the HTPD patrols the Swamp and is the first responder while most search and rescue is performed by Chatham Twp. During this meeting it was discovered that the Swamp has a full time federal law enforcement officer with powers to arrest and carry weapon on duty who lives in Meyersville. The HTPD has his cell phone number. Why the HTPD is the first responder in the Refuge is a HT patrolman and not the federal officer was not answered.

Individual citizens voiced serious complaints. One has a formal complaint that is being investigated by the Morris County Prosecutor while "several" families and individuals said they were mistreated, especially young drivers.

In July, the TC announced the hire of an officer to replace one who left to another department a few months ago. The officer, a HT resident, is currently working in Bernardsville as a dispatcher and in Point Pleasant as a special officer. A Spanish speaker, he will be hired as a "special" probationary here in HT until May of 2013 as he will need more training. He is EMT certified.

The rising costs of the department loom large in the thinking of the TC, though rarely in the comments from the public that attends the meetings. Compensation costs come in six categories – (1) salary and payroll taxes, (2) over time, (3) pension expense, (4) healthcare and dental of active officers, (5) healthcare for retired officers, (6) off duty police work.

Pension and Healthcare are the items that are most concerning to current and future budgets as they are all over the nation in local, state and federal budgets. The \$70 billion pension fund for our retired officers is administered by the State but it is grossly underfunded by \$36 billion, and that underfunding assumes an 8% investment return, a figure that the historically poorly managed fund has not achieved. Though managed by the State, municipalities have to fund payments based on the number of retired and active officers. The required HT portion varies and is not predictable – in 2012 it was only 23% of salary (a "windfall") while in 2011 it was over 33%. It is likely to go back to 30-35% in 2013 -- a big increase that will pressure property taxes and or force cuts elsewhere. And to make things worse, state law prevents a municipality from socking away more in good times to fund this expense.

Healthcare has a high inflation rate. Healthcare premiums are mostly paid for by HT while the state sets the percentage paid by employees. In 2011 the cost for healthcare for retired

officers (12 people) was \$270K. Retired officers make no contribution to the healthcare costs. An officer earns free lifetime healthcare after 25 years of service only 15 of which have to be in HT. As will be shown below, the post retirement cost of healthcare is an important factor in the cost of an average officer.

Toting it all up, the TC showed that the average cost to put a patrolman on the force in HT is \$209.4K – 47% of which is salaries and payroll taxes and 53% is current and post-retirement benefits:

Salary - \$98.6K Payroll Taxes - \$7.5K Pension - \$21K – likely to go up in the future Healthcare - \$39.4K – might go down Retirement Healthcare - \$42.9K Total -- \$209.4

Outside police work performed for a private company such as directing traffic at Wightman's Farm at Halloween or JCP&L maintenance sites. By an 8 year old ordinance, HT charges \$56 per hour for this work - \$50 of which goes to the officer while \$6 stays in HT. In 2011 there were 4462 hours of such work – equal to about 3 full time officers. These hours are not pensionable but it is not clear that the \$6/hour (\$26.8K for the year) that HT receives for contracting out its police force in this manner makes sense.

Benchmarking. Over the last few years, the TC has used benchmarking to compare various department costs with other neighboring towns. This exercise was expanded to include 10 figures of merit and was presented at the August meeting. The 10 figures included cost per mile of road patrolled, cost per square mile, cost per capital, non-salary cost per capita, healthcare cost per officer on family plan, wage scale (number of steps/years until reach top scale), 2012 salary increase, change in staffing level over last 5 years, violent crime per 1000 population and property crime per 1000 population. All figures showed HT roughly in the middle of the pack (if adjustment were made) with the striking exception of healthcare cost per public safety officer on a family plan. HT costs were fully twice the other towns suggesting that our benefit package is either over priced or more generous than other towns.

To tackle these important and complicated issues the TC decided that they needed expert help and hired a consultant via a formal proposal process. The TC "did their homework" before going outside and was looking for input on five items – (1) organization and staffing model (12 hour shifts currently), current PBA contract, current work rules and regulations, resources and technologies, organizational efficiencies and shared services (ex. detective). The TC said there was "good interest" from 12 consultants for the job. PowerPoint Slides on these presentations are available on the Harding Township website.

Special Meeting of the Township Committee, September 4, 2012

Present: Alf Newlin, Lou Lanzerotti, Nic Platt, Ned Ward; Absent: Marshall Bartlett This meeting centered around the retirement of the Chief of Police and the interim plans and the hiring of a police consultant.

Harding Township officials were notified Friday morning August 24th that Kevin Gaffney, after 30 years in the Police Department, the last 16 years as Chief, plans to retire. Mr. Gaffney's resignation is effective immediately; he will use his accumulated sick and vacation time, and will officially leave the Township payroll on December 1st. Chief Gaffney indicated that he will be available to the Township as needed during this interval.

The Harding Township Committee is pleased to announce that Sergeant Mark Giansanti was temporarily appointed as Officer-In-Charge of the Police Department. Sgt. Giansanti is a 23 year veteran of the force. The appointment, made by Chief Kevin Gaffney, is effective immediately. Additional details can be found on the town's website: www.hardingnj.org.

Sgt. Giansanti gave an overview of the police activities over the past month. In addition to regular policing activities the officers are going door to door in our senior community to make sure they are prepared for an emergency, such as the storms we had last year and know who to call. This also gives the officers an opportunity to get to know the seniors. The officers will be making similar calls to the businesses in town to let them know what's happening.

The township released an RFP for a police consultant. In addition to facilitating with the police contract, the RFP included providing research and recommendations to the township. The township committee hired Ted Ehrenburg of Blue Shield Consultants to provided those services. Mr. Ehrenburg will be interviewing the township committee members, the township administrator, and the officer-in-charge over the next month. One of the first priorities is to look at the current staffing level. The analysis is scheduled to be completed in November with a report being issued in December.

A resolution was passed to hire a class 2, special police officer. A class 2 officer is a graduate of the police academy who has full police powers within Harding township, but not in the rest of the state. This new officer will be eligible to be promoted to a township police officer next year.

ENVIRONMENTAL COMMISSION, JULY 10, 2012 LIAISON REPORTS

Board of Adjustment (BOA) – H. Symonds reported that the BOA met on June 21, 2012 and has been updated on the activities of the EC.

H. Symonds reported that the Cell Tower application has been postponed until the July 19, 2012 BOA meeting. A general discussion ensued regarding the EC's recommendations pertaining to the environmental concerns of installing a cell tower at either, the NJDOT or the Seventh Day Adventist Church site. R. Clew summarized the critical issues as being the preservation of the viewscape and limiting the impact on Primrose Brook. Recommendations include: tower height limited to 120'; utilization of a natural gas powered generator to avoid oil being transported onto the property; diking the maintenance parking area to prevent run-off into the Brook; and the placement of trees or other screening material at the base of the tower to minimize the visual impact.

It was the consensus of the EC for H. Symonds to prepare a position statement along these lines, to be read into the record at the next public meeting of the BOA.

Another subject was the Variances requested for the development of the Hurstmont property. K. Meister shared information obtained from the Master Plan of Harding Township pertaining to the density of rural development and surface and subsurface water quality. He expressed concern regarding the density variance, septic requirements and the impact on ground water supply pertaining to the Hurstmont property application. A general discussion ensued resulting in the EC postponing the position statement until a new proposal on the Hurstmont property has been submitted to the BOA.

Harding Open Space Trust (HOST) – J. Morgan reported that HOST met on June 13, 2012 and has been updated on the activities of the EC. He reported that HOST objected to the cell tower at

the church site due to its proximity to the Anderson Woods and the Glen Alpin property and the negative impact on the viewscape. HOST will present a position statement at the next BOA meeting. J. Morgan also reported that Mr. MacCowatt would contact J. Murray regarding the easement documentation and website development.

PROJECTS

Easement Stewardship – J. Murray reported on the monitoring efforts and noted that the EC was very well represented for both the June 9^{th} and June 16^{th} visits. He expressed his appreciation to the EC; especially noting S. Krizko who personally visited the largest number of easements during the monitoring visits.

- J. Murray reported that the inspection of 45 easements was completed and that there were approximately six easements in which environmental issues were discovered. He agreed to prepare letters to all of the property owners, expressing appreciation for their cooperation in the monitoring process and offering best practice recommendations to those in which issues were identified
- J. Murray stated that easement monitoring will continue in October with the review of eight properties with steep slope easements, while general easement monitoring is scheduled to continue in the Spring.
- J. Murray reviewed the next steps of the easement stewardship including: database development, easement violation standards, feedback letters to easement holders, self-monitoring guidelines, letters to self-monitoring associations and organizations, guideline development for easement baselines, monitoring schedule and notification to property owners.

The EC complimented J. Murray and his wife, Joyce for their extraordinary efforts in preparing and organizing the easement monitoring project. J. Murray expressed appreciation to several members of other boards and committees who participated in the easement monitoring project including: Peter Saulnier and his daughter Matherin, David Dietz, Ginny Moriarity, Larry Weppler, and Chris Allyn. He agreed to send letters of appreciation to these individuals.

Street Lights/Energy Efficiency Analysis – H. Symonds reported that implementation of Phase One of the light reduction has been completed. A general discussion ensued resulting in a recommendation for H. Symmonds to further review the light reductions with G. McKane and N. Platt.

Regarding Phase Two, H. Symmonds stated that statutory regulations indicate that municipalities are to reimburse private communities for services or to provide services in a qualified private community in the same fashion as the municipality provides services in public roads. The analysis indicated that a reduction from thirty-eight lamps to nine lamps could be considered at Harding Green; and a reduction from seventeen lamps to three lamps could be considered at Shadowbrook. A lengthy discussion ensued regarding the reduction of lighting at Harding Green and Shadowbrook.

H. Symonds suggested, as an alternative to the light reduction, that a Smart Start program similar to the one offered by the State be explored for the Harding Green and Shadowbrook communities. Incentives are offered to communities for replacing low efficiency fixtures with high efficiency alternatives. He provided R. Bruno with information on the State program for further review.

It was noted that the EC's goal pertaining to the light reduction has been to reduce light pollution and carbon output with an added benefit of financial efficiencies.

Proposal on the use of Solar Energy – R. Bruno presented the cost information he received thus far from several entities. He further reported on the status of the legislative regulations pertaining to solar energy. Upon receipt of additional information, R. Bruno will present a proposal at the September meeting of the EC.

Proposal on Recycling – R. Clew reported on the current recycling program and suggested opportunities for the EC to become more involved. He proposed that the EC would coordinate with the DPW to raise awareness on the recycling options as well as host a Harding Township Recycling Event. He will work with T. Toribio to coordinate the event scheduled for 2013. He also suggested working with the Library for document shredding and the Health or Police Department for medication disposal. R. Clew will present more details concerning the proposed event at the September meeting of the EC.

New this year is our *Digital Learning Initiative*.
