Preliminary Capital Budget for 2014 Discussed, March 17, 2014

At the March 17 Township Committee meeting, the preliminary Capital Budget was discussed in some detail. It will be formally introduced in April and adopted in May.

This first cut budget calls for \$750K in outlays. Municipal building will get \$20K of improvements, upgrades and new AV equipment, including a new sign on the Blue Mill Road entrance to Kirby Hall. This sign survived Sandy, but is rotten and quite inaccurate since our court is now shared with Madison. "Public Improvements" - roads, tennis court (tentatively), other -- will be allocated \$105K. (The TC continues to seek citizen input regarding the advisability of spending \$50K to renovate the tennis courts adjacent to Kirby Hall.) The Farm at Harding needs \$25K of maintenance. Future COAH obligations will be funded by \$215K. A new SUV for the Police department will cost \$35K and other Police Dept items add up to \$31.5K. And DPW shopping list totals \$318K and includes an \$80K skid steer with attachment which will eliminate rental expenses.

Since the operating budget (discussed above) called for only \$450K in funds to be set aside for capital expenditures against these potential outlays of \$750K, the capital fund balance will decrease substantially in 2014, from about \$461 at the beginning of the year to \$161k at the end.

Township Committee, March 17, 2014

Township 2014 Budget Formally Introduced

On St Patrick's Day, the Township Committee (TC) formally introduced the 2014 budget. The budget calls for lower taxes (7.3% -- you read that right!), paydown of debt, increase in capital budget, and maintenance of surplus. But before we get too excited, understand that this budget is only for the township operations and local open space spending (together about 28% of your property taxes). And though the Morris County Freeholders have promised to hold county taxes (27% of your property tax bill) flat, the Harding Board of Education has proposed a budget that increases taxes by about 2%. School related taxes drive about 43% of your tax bill.

And importantly most of the 7.3% decrease in municipal taxes is driven by Federal Emergency Management Admin (FEMA) reimbursement for Super Storm Sandy. Sandy has caused spending and taxes to spike up last year (2013) and then drop sharply this year as Harding Township (HT) received reimbursement monies. So next year, without this non-recurring inflow, net spending and taxes are very likely to pop back up.

Before the presentation dove into the budget details, it reviewed a few other items:

Where Do the Taxes Go?

Harding collected \$21.9MM in property taxes last year. The School got the biggest piece (43%) followed by the Township (27%), Morris County (26%), Harding Open Space Trust (3%) and County Open Space (1%). The assessed value of all of Harding's taxable properties is just over \$2 Billion (\$2.043B) while the average resident pay about \$13.5 thousand in property taxes on her "average property" valued at \$1.25MM.

Township Debt -- AAA and Declining

Harding has about \$8.1MM in debt outstanding, down from \$11.3MM in 2008. The TC has a policy of paying down debt and forecasts it will be all repaid by 2028. This year's debt service just over \$1MM. Affordable housing drove 40% of the debt issuance. Other causes were Open Space (23%), Municipal spending (16%), "Wildlife" (13%) and Glen Alpin (8%).

Note that Margetts Field is NOT on the list, as that debt was extinguished in 2013. "Wildlife" is actually a property purchased many years ago in a settlement with the EPA in lieu of having to remediate an old Harding dump site.

Open Space

As mentioned above, 3% of your property taxes. The TC was given the power by referenda several years ago to tax 2 to 5 cents per \$100 of assessed valuation towards open space. In 2008, both HT and Morris County taxed at 4.5 cents per \$100. The County has cut its rate steadily to 1 cent. Some have criticized the County for this 78% reduction as a politically less painful way to show fiscal control. The current budget calls for 3.5 cents per \$100, the same rate as in 2013. This is the rate that HOST, Harding Open Space Trust, recommended to the TC. At current property valuation, this tax will raise about \$710K. Fully one third of this money will go to debt service that was associated with OS purchases. The OS Trust Fund had a balance of \$1.64MM at 1/1/14.

Affordable Housing - Must Build More in the Near Future

The Council on Affordable Housing (the genesis of which was the landmark Mount Laurel court decision) requires that all municipalities make affordable housing available. The cost of the required housing units (the number of which are determined by a complex formula based on growth in the town) is born by the municipalities. HT's COAH housing is The Farm at Harding located on the corner of Kitchell Road and Woodland Ave. Debt service on this asset will be \$398K in 2014 while net revenues (rent less operating costs) will be about \$220K. Therefore the HT budget will bear about \$178K to support that facility.

Governor Christie attempted to cut back the COAH liability but was stymied by affordable housing advocates in the courts. It now appears that HT will have to provide more COAH units in the future, the prospect of which has been on the TC's radar for some years.

To meet its mandate under the so-called 3rd Round rules, HT's plan is to build two more units at The Farm, allow accessory residences and consider a group home.

Appropriations -- Where Will the \$8.54 Million Go?

HT will spend \$8.54MM in 2014. About two thirds will be appropriated by the 11 departments that make up township government. The balance is for debt service, COAH and other expenses not allocated to the 11 departments.

The Police Department is the largest -- accounting for \$2.84MM (about half) of the \$5.6M of all department spending. Compensation and benefits are \$2.35MM. Health care for retired police personnel is \$316K and other department expenses (gasoline, etc) are \$168K.

The Department of Public Works is the second largest -- at \$939K, about 17% of all departments spend. Compensation and benefits are \$534K while other expenses (fuel, salt, contractors, asphalt, etc) are almost \$396K. Retiree health insurance is just \$8.9K. In descending order, the other departments are Administration (9%), Finance (6%), Construction (5.5%), Health (5%), Legal Services (3%), Zoning Board (2%), Joint Court (1.5%), Engineering (1%), and Planning Board (1%). Legal, Engineering and Joint Court are all outsourced and have no payroll. Reflecting the personnel intensive nature of a

municipal government, salaries and benefits account for 77% of department costs while the other costs are just 23%.

And reflecting the rising costs of healthcare and past contracts, 35% of healthcare costs are for retired employees (mostly police officers) while 65% of healthcare costs are to pay for active employees.

Budget Highlights

The TC said that the 2014 does 5 things. (1) Ensures HT's low tax structure, at least the part that the TC controls. (2) Returns FEMA reimbursement of \$147K back to the taxpayers. (3) Maintains a health surplus. (4) Increases the capital budget by \$60K. (5) Increases snow removal budget.

In 2014, overall spending will actually drop 4% from \$8.88MM to \$8.54MM. But \$246K of that \$341 reduction is caused by having no emergency appropriation for Super Sandy. More structurally, health insurance expense is forecast to drop \$168K due to employee contributions (4th year for most employees and 1st year for police). Non-union employees have had a high deductible plan.

On the income side, "general revenues" (non tax revenues) are projected to increase about 2.5% due mainly to the FEMA Super Sandy reimbursement. This permits a 7.2% reduction in tax take needed to balance the budget. But without that FEMA reimbursement, taxes STILL would have been reduced almost ½ percent.

But the assessed value of all taxable Harding properties has again declined (by \$15MM or 0.74%) do property owners won't see the 7.2% decrease in taxes. Rather it will be more like 6.4% as the rate drops from \$0.282 to \$0.264 per \$100 of assessed value. Driving down the assessed value are a number of factors, among the property tax appeals, Open Space purchases which take property of the tax rolls, and new farm assessments. Recent new construction and home improvements are not enough to offset those depressing factors.

The Bottom Line for "Average Homeowner" - \$204 Less in Taxes

The average home (\$1.06MM assessed value) will see its municipal tax bill cut about \$200 from \$3016 to \$2810 in 2014. Remember, the County taxes are promised to remain unchanged while the Harding School taxes are rising.

The TC ended with a review of financial challenges which include (1) the ongoing PBA contract negotiation, (2) benefit cost increases, (3) NJ State underfunded pensions and (4) uncertainty around COAH policy and mandates.But the TC continues to hold the following objectives: (1) fund quality of service consistent with HT's tradition of "trim government", (2) conservative expenditure of tax dollars, (3) continued debt paydown, (4) maintain strong financial position and AAA bond rating, (5) fund capital expenditures on a cash ("pay as we go") basis.

Board of Education Meeting

Highlights, Monday, February 24, 2014

The Superintendent gave his "State of the District" report which covered all aspects of Harding activities from student activities, academic standings, physical improvements, funding, and administration. This comprehensive report of over 70 slides deserves a visit to the school district's website (hardingtwp.org) for the full presentation. Two items are briefly mentioned here. Most notably, median test scores are improving in all grades relative to those throughout the state and within our peer group, although those in the lower quintile did not show as much progress, indicating that more attention to this area is needed. Another topic of concern was the transition from the familiar NJSAK testing program to the national PARCC. The implementation of this program by the state came rapidly with the general feeling that there was inadequate time and information for the teachers to prepare their students. (This is the last year for NJASK; next spring – 2015 – PARCC will replace NJASK.)

The next item on the agenda brought up the topic of implementing the snow day schedule – should it be changed from the end of the school year as presently, or should it be moved up to spring break or other times. This caused quite a discussion, not only among the Board members but also from the teachers and parents in attendance. On one hand, the lost days precluded the teachers from using that time for preparing their students for the NJASK tests. On the other side, inserting make-up days into the spring break interfered with planned vacations and other activities, both by teachers and parents, and furthermore was not in sync with the snow days scheduled by Madison High, causing further disruption to family schedules. The parents and teachers spoke against changing the schedule. While the Board members wanted the time to best prepare the students for the NJASK, they were sympathetic to the concerns raised. At the end of the discussions and comments, the Board asked the Superintendent to review all the options and make a recommendation at the next Board meeting (which will occur on the next Monday, March 3rd).

Board of Education Meeting

Highlights, Monday, March 3, 2014

More than a dozen teachers, parents, and interested citizens were in attendance. The main focus of this meeting was the presentation of the 2014/15 "preliminary" budget, so called because it must be approved by the county and state Boards of Education. As a practical matter, this <u>is</u> the budget, and it would be very difficult to change at this point in time. It is a "business as usual" budget which carries on the existing programs of the District while making allowance for a projected sharp increase in mandated health care costs, and considering the outcome of the teacher union negotiations. This presentation can be viewed on the District website <u>Hardingtwp.org</u>, and is well worth a look. The outcome is that a 2.81% increase in funding will be required by Harding taxpayers, and without voter approval. Most of us may have thought that the maximum increase without a vote was 2%, but there are some nuances (not loopholes, exactly), that come into play. One is that there are some exemptions such as healthcare costs which can be added on to the 2%, and then there is the recovery of money that wasn't asked for in the previous two years, explained as follows: Since the 2012/13 year had a 1.78% increase, and the 2013/14 had 1.50%, and each could have been 2%, this leaves a recapture of .22% and .50% available. Only about \$58K will be used, however, leaving the opportunity for another greater than 2% increase next year, without vote.

The second notable issue was the possible adjustment of snow days on the school calendar, which were carried over from the last meeting. As requested, the Superintendent provided information regarding possible impact of a change such as teacher availability and student benefit. After a brief discussion, the Board felt that, unless more snow days occur, the schedule should be left as presently promulgated, but all agreed to consider alternatives when addressing next year's calendar.

(Note: the purpose of this brief report is to help Harding residents connect with the School by highlighting significant items addressed by the Board. The "meeting minutes" are filed by the Board Secretary and placed on the Harding School website for all to view, generally about a month after the meeting date.)

HARDING TOWNSHIP SCHOOL

Alex Anemone, Ed.D., Superintendent of School

Spring is finally here. Our spring athletic season (girls lacrosse, boys lacrosse and coed track and field) has begun and we are nearing the end of our budget season. At the Board of Education meeting held on March 3, the Board approved the tentative 2014-2015 Harding Township School budget. The budget has already been sent to the executive county superintendent and will be presented to the Harding Township community in greater detail at the May 5 BOE meeting. That meeting, also referred to as the public hearing, will begin at 7:30p.m. in the HTS Library/Media Center. The tentative budget maintains our current staffing configuration as well as all co-curricular activities. Despite rising health care costs related to the Affordable Care Act and relatively flat state aid, the local tax levy will only rise 2.81% with the total budget rising only 2.01%. We thank you for your continued support and look forward to a fantastic finish to the 2013-2014 school year. Full details can be found on our website.

On March 21, the PTO unanimously voted to fund a grant - estimated at \$29,250 - to replace all SmartBoards in the elementary school with newer models. This will enable our teachers to integrate technology into their daily lessons and allows our students to build and develop college and career readiness skills from the day they enter HTS.

Additionally, and on behalf of the staff and student body, I would like to offer special thanks to the PTO and extra special thanks to our media specialist, David Harris for tying two other PTO grants together in an educational way. Starting with the 2012-2013 school year, the PTO fully funded the \$105,000.00 Digital Learning Initiative, purchasing iPads for teachers (grades K-8) and students in the middle school (grades 5-8). This year, as part of their continued support of the Battle of the Books, the PTO generously bought multiple sets of novels, eBooks, and for the first time, online audiobooks. These audiobooks can be accessed on any digital device, including our iPads (plus cell phones, laptops, desktops, etc.) Mr. Harris has set up a common district wide login for students and teachers to use. We are hoping that the audiobooks will provide another pathway to learning as students explore diverse literature to prepare for the Battle of the Books contest coming later this spring.

Planning Board Meeting February 24, 2014

Roll Call: Mr. Dietz absent.

<u>Administration of Oath</u>: Ms. DiTosto and Messrs. Newlin and dePoortere were sworn in. <u>Minutes</u>: The minutes of the meeting on January 27, 2014 were approved after some comments and minor revisions.

Announcements/Reports/Presentations

- Mr. Saulnier reported that Mr. Drew should be back in attendance in March.
- Regarding the Board's budget, Mr. Saulnier reported that he increased the numbers for engineering and planning at the suggestion of Ms. McKane. The Board agreed to submit the budget to the Township Committee.
- Mr. Saulnier reminded the Board of the need to review the Board's professionals. This will be done after the next meeting in executive session.
- Mr. Saulnier wondered whether any educational sessions need to be conducted for the Board ("we'll think about it").
- Mr. Schliefer reported that the Board of Adjustment was considering the issue of generators placed in front of buildings. Also, this Board's annual report should be coming next month.
- Mr. Clew reported that the Environmental Commission will be focusing on education, and that clean-up day will be held in April.
- Ms. Ditosto reported that HOST had given a presentation at the last Township Committee meeting; this can be viewed on the township website. Of note, the open space tax should remain at \$0.035 per \$100 of assed valuation, and \$122,844 is being contributed to the closing of Frelinghuysen Lot 4.03.
- Mr. dePoortere reported that CPAC had met last week and discussed goals for 2014. The annual fishing derby will be held on April 12th, and CPAC will support the clean-up day.

Extension of Time Request

PB 1-09, **Applicant 151 Madison Avenue Corporation,** Block 4, Lots 15, 15.03 and 15.04, 610 Van Buren Road, Minor Subdivision. Action: Request for a two-year extension of deadline for installation of subdivision improvements. No improvements have been completed, in part due to the real estate market. No building permits may be issued until improvements are completed. Town is still holding deposit which doesn't need to be increased. Mr. Hall suggested granting the extension from the original August approval date. Extension approved.

Application

PB 04-13, **Applicant Wesley and Mary Margaret Lang**, Block 19, Lot 7, 521 James Street, Minor Subdivision Approval. Action: Continue Public Hearing

Mr. Hall had prepared draft resolution which was revised based on Mr. Fox's review. One issue was whether the water line could be extended to the subdivision. Ms. Olcott argued that this would be inconsistent with the master plan and the philosophy of the town which is to not

expand infrastructure. While extensions had been built along private roads, none have been done along public roads. So the proposed cistern will stand. Mr. Fox reported that the drive was adjusted, and storm water management had been relocated to the other side of the drive to provide more room for the bridle path.

Still needed were a drive profile and paving plan, and metes and bounds for bridle path. Also, since the septic system must be relocated, a bond must be posted for that and other improvements (fire protection and storm water management) before recording. Mr. Hall reviewed revisions to the resolution which was then approved.

Other Business

Mr. Saulnier then led a discussion of possible issues for the Board to investigate in 2014. Items were also suggested by the public. These included the following:

- Should swing sets and play sets be allowed in setback areas?
- Should fencing and related ordinances be reviewed?
- Do we need an area outside of the building box to prevent building up to conservation easements? Or put a buffer around conservation easements?
- Should relief be granted from setback requirements for non-standard lots?
- Should greater relief be granted to allow generators in front yards with proper screening?
- Should the ordinance which applies to houses that are less than 150 feet from the front lot line and limits coverage to limit appearance of bulk be reviewed?
- Should the ordinance that relates to residential housing in B-1 zone and the applicability of FAR be reviewed?
- Should the proposed septic management protocol designed by Morris County be considered?
- Should the board consider the issue of accessory structures in front of houses?
- How can lighting restrictions be enforced?
- Should the zoning list be updated to designate public lands as public?

Wildlife Management Committee

Canada Geese: In its efforts to control the Canada geese population in Harding Township, the Wildlife_Management Committee is asking residents to help identify locations where Canada geese might be nesting in the Township. Volunteers are ready to assist by treating eggs so that they will not hatch (called addling), using methods approved by the Fish & Wildlife Service.

If you have a body of water on or near your property, or have seen goslings in prior years, it is likely that you will have nests again this year. Harassing birds during the nesting season, or removing eggs from nests is counterproductive, because it will encourage the birds to renest out of sight, where eggs can't be found or effectively treated.

Early identification of bird pairs and nesting sites does much to assure the process. Migratory geese will leave the area by the end of March. Resident bird pairs will then be more visible, usually claiming an area and keeping other pairs away. If you think your property is a potential nesting site, if you see obvious pairs, would like to learn more about what to look for or need help in spotting or treating nests, please contact the Committee at <u>khmeister3@gmail.com</u>, (973) 605 8274 or <u>r.a.shields@att.net</u>, (973) 267-5673.) A property conducive to nesting should be monitored weekly throughout the nesting season, which starts in mid to late March and ends mid May. For help and best results, please call us sooner rather than later. Addling eggs controls the growth of the goose population. Done properly, it is both, humane and effective!
