BOARD OF EDUCATION

Meeting Highlights: Board of Education Meeting 1-04-2016
Board Organization: The reorganization meeting of the Board of Education
saw the taking of the oath of office by Board members John Flynn and Howard
Kotkin who had been re-elected in November. By unanimous vote of the five
member Board, Davor Gjivoje and John Flynn were re-elected as Board
President and Vice President, respectively. President Gjivoje indicated that
the membership rosters for the Board committees would be developed, and

announced at the January 18th public meeting.

Budget. A preliminary report on the school budget (fiscal year beginning July 2016) was presented by Superintendent Matt Spelker. The budget remains a work in progress as the Superintendent and Business Administrator, Bob Brown work on the discretionary portion of the budget. Major budget assumptions include no change in staffing levels and no change in overall enrollment. About 80% of the budget is fixed in terms of salaries and benefits, and about 5% of the budget is devoted to paying off the school debt (which expires in July 2018). It is anticipated that health benefit costs and dental costs will increase by 10%-12% and by 5%, respectively, this year. Out-of-district placement costs for special education students (always a difficult expense to predict) is expected to increase by 4%-6%. The Board is in its second year of the faculty contract, which calls for a 2.6% increase in salaries. Thus, the Administration indicated that it is using a zero-based budget process for handling the non-fixed (discretionary) portion of the budget. Some of the discretionary expenses this year will likely include paving the school parking areas and a new heating/cooling system for the gymnasium.

The school budget revenue history shows increases of 1.78% (2012-2013), 1.5% (2013-2014), 2.6% (2014-2015), and estimated 2.89% (2015-2016). The latter two increases are inclusive of allowable exemptions by law (e.g., for health benefit increases and banked capital accumulated from prior years).

Future budget presentations will occur on February 22 (Preliminary Budget II), March 21 (Tentative Budget formally presented to the Board), and April 18 (Public Hearing on budget).

Curriculum. As previously reported, the Board has established a policy for monthly curriculum presentations. The January presentation was by Middle School English teacher Lisa Werner on the use of Google Docs in the classroom for enhanced learning and teacher-student interactions and assessments of learning. A committee of faculty has devoted themselves to developing the use of this educational enhancement and to advising all faculty on the methodology and practices. Several parents at the Board meeting expressed very positive perspectives on this program in the context of their observations of their children's use and performance.

The curriculum presentation at the February 1st Board meeting will be by the Middle School science teacher, Dr. Michael Gervis. The topic will cover Next Generation Science Standards.

The Board entered into executive session to discuss the sending-receiving contract with the Madison school district.

(Note: the purpose of this brief report is to help Harding residents connect with the School by highlighting significant items addressed by the Board and are not "meeting minutes". Minutes are filed by the Board Secretary and placed on the Harding School website for all to view, generally about a month after the meeting date.)

NEW VERNON FIRST AID SQUAD

2015 was a Busy Year for New Vernon First Aid Squad—Volunteers Needed Last year was a busy year for the volunteers of the New Vernon First Aid Squad. In 2015 the Squad responded to 302 emergency calls. These included 6 CPR calls, 73 medical calls, 41 falls/fractures, 40 motor vehicle accidents, 23 calls for shortness of breath or difficulty breathing, 9 bicycle falls, 7 seizures, 6 calls for fainting, 5 lacerations, and 3 calls for strokes. Beyond responses to private residences and local Harding Streets, the Squad responded to calls at the Harding School, Wightman's Farm, the Minuteman Restaurant, Jockey Hollow Park, The Great Swamp, Interstate 287, as well as mutual aid calls to surrounding communities like Morristown, Madison, and Basking Ridge. One of

the calls to Jockey Hollow involved a hiker who was one mile down a hiking trail. Squad EMT's worked with the U.S. Park Service to bring the patient to the ambulance and provide transport to the hospital. Two of the motor vehicle accidents involved a car into a building— one at the Great Swamp Visitor Center and one at the Village Bistro restaurant. The squad also responded with two ambulances to a severe accident on I-287 in November that had three fatalities, over 12 patients, and included a total of eight ambulances (6 from neighboring communities), two paramedic units, and two air-medical helicopters. This was a call where we worked in partnership with our parent Volunteer Fire Department, which quickly and effectively extricated patients trapped in a van. Our Fire Department is also actively recruiting volunteers for this essential community role. In October the squad provided free CPR training to 16 members of our local

In October the squad provided free CPR training to 16 members of our local community. In November the squad did its annual CPR re-training for both its own members as well as for the entire Harding Township Police Department. The squad carries and is qualified to administer Naloxone for Opiate overdoses, epinephrine auto-injectors for anaphylactic shock, an automatic external defibrillator (AED) for cardiac arrest, supplemental oxygen, chewable aspirin for cardiac related chest pain, and glucose for diabetic emergencies. It also carries the usual assortment of splints, bandages, instruments for assessing patient vital signs, and devices to lift, carry and transport patients. The Squad is dispatched by the Morris County Office of Emergency Management through the 911 call center. The First Aid Squad is comprised entirely of volunteer members and is available 24 hours a day, 7 days a week to serve New Vernon.

Volunteers Needed! The squad needs at least 7 new members in 2016 in order to continue to serve the community with excellence. New members are needed both as EMT's and separately as drivers—the Squad provides all the training. TOWNSHIP COMMITTEE

Meeting Note: January 2016 2016 Budget Introduced

All members were in attendance.

Township Committee awarded 12 contracts for services - 5 legal, audit, engineering, 2 insurance, bond counsel, planner and tree officer. The firms and individuals were appointed at the re-organization meeting and now the contracts have been formally approved.

The preliminary 2016 Budget was presented and discussed at this meeting. Formal introduction of the budget will occur at the February TC meeting while public hearing and adoption will be in March. March will also see the introduction of the 2016 Capital Budget for long lived items.

The preliminary budget calls for a 1% increase in spending to \$8.612 million and increase of \$119.7K. This would require an approximate 1.9% increase in property taxes - this is more than the spending increase because the taxable base (the assessed property value) continues to slide (by about \$13mm or about 1%) as it has for years due to tax successful appeals and open space purchases.

To put your property tax bill in context, remember that it funds five entities – Harding Schools (about 46%), Harding Municipal Services such as police, roads, health depart, etc (25% of your tax bill), County services (24% of your tax bill), Harding Open Space aka HOST (about 4% of your taxes) and County Open Space (1%).

Harding School preliminary budget was also introduced and is covered in another report in this issue of Thumbnail.

Thumbnail does not cover the County government (the Civic Association would warmly welcome a citizen who wanted to take on that task!) but word is that the County tax increase will be about 3.05% -- from .262 to .270.

This report focuses on only the Harding Municipal Budget and HOST - the two pieces for which the TC has responsibility for and authority over.

By state law, municipal budgets must balance, unlike the federal budget which is consistently in the red since Washington can print money.

A Word on Debt; Harding Township is a AAA rated entity and the policy has been to pay down the debt we do have. From 2009, when debt was \$13.8mm, the outstanding has been cut by over half and is projected to be \$6.64mm at year end. On current course, debt will be eliminated by 2028. However, large needs for affordable housing and/or open space purchases could change that projection dramatically.

A Word on Open Space Tax; Open Space tax is set by the TC at zero to 5 cents per \$100 of assessed property value. In Harding it has varied from 4 cts in 2009 to a low of 3.5 cts in 2013 and 2014. Last year it was raised to 4 cts. A decision has not been made on the level for 2016 and the Open Space Committee did not make a recommendation at its recent presentation. Mayor Platt has expressed his strong preference to raise it to the maximum of 5 cts.

Harding Appropriations (aka spending); the total 2016 spending is pegged at \$8.61mm of which \$5.86mm (70%) is for the several departments while the balance of \$2.75mm is not allocated from departments but includes things like debt service, capital improvements, etc.

Looking at the department budgets; 45.6% is for police, 20.6% is DPW and 10.5% is for Admin & Clerk. The other 22.3% covers the other departments – Finance & Tax, Construction, Health, etc. The department budgets are dominated by spending for people - salaries and payroll taxes (53.9%), pensions (6.8%), health benefit (10.4%), retiree health insurance (6.1%). Only 22.5% of the departmental budgets are spent on things like supplies (significant for DPW) and services.

Drivers of the 1% expenditure increase were specified as:

- (1) Health Insurance rate increase of 4%,
- (2) Health insurance benefit for a new employee,
- (3) Cost of living adjustment of 2% to pay rates,
- (4) Emergency fund increase of \$30K,
- (5) \$50K increase to funding for capital improvements -- \$450K to \$500K.

Announcements/Reports/Presentations

Mr. Schliefer reported that cell tower activity had begun anew at the Board of Adjustment. One other application was presented, and a site meeting was set and more information was requested. Mr. Clew reported that the Environmental Commission had met regarding 2016 goals. Mr. Platt said that a new lighting ordinance was needed that had better descriptions. The term "foot candles" was not helpful when purchasing a fixture. The township Committee will be submitting something to the Planning Board on this subject. Mr. Jones reported that HOST had met to set goals for 2016, to set parameters on expenses, and to plan a clean-up at Glen Alpin. CPAC wants to remind residents that there must be several days of cold weather before the skating rink can be flooded. Of course property taxes will generate the largest portion of revenues (64%), followed by surplus - excess of revenues over expenditures from prior years (21%), energy tax receipts - rebate from the State (5%). Municipal revenues, fees and fines (5%), UCC Revenue (3%), FEMA Reimbursement - last payment from storm Sandy (1%), and delinquent tax (1%).

As we said at the top of this report, in order to raise the revenue to cover the budgeted expenditures, the property tax rate is preliminarily pegged to rise about 2% to .273 per \$100 of assessed value.

As of this writing, the budget presentation has not been posted at the township website. But for those interested, we'd expect it to be there soon.

DID YOU KNOW???

Harding Township Board of Health has adopted a new septic ordinance #02-2015-422

Amending Chapter 422, Article III Background:

The original septic ordinance in Harding Township was adopted on October 9, 1973, and established its very first Board of Health. This ordinance has had minor revision throughout the years. There was a major revision made in 1991 which came about as a result of a significant change made in 1990 to the New Jersey State Code.

This ordinance has served us well. It has protected the ground water and streams that Harding residents both expect and cherish. The mandate the Board of Health placed on our professionals when we undertook this review was that any revision to the current ordinance could have no deleterious effect whatsoever on our water quality and have no effect on zoning.

The decision to undertake another revision came about after the BOH saw applicant's engineers coming in with plans based on advanced technology that allowed for the design of new septic system embracing the latest innovations. The *drip* and *aerobic treatment systems* are just a few of the many changes that have taken place over the last ten years. This, coupled with another major revision to the State Code in 2012, led the Board of Health to decide that Harding's septic ordinance should be updated and revised.

Purpose:

The purpose of these revisions is to reflect improvements to wastewater treatment technology and the current State regulations. The revisions provide for a more user-friendly code while holding paramount the protection of our groundwater resources. Additionally, the revisions reduce the amount of space required for septic systems and thus reduce the amount of clearing and associated tree clearing necessary for septic system construction.

The revised Health Code reduces the setback distances required for various septic system components. This is the result of improved construction and testing requirements for those components. With the exception of setback distances from property lines, the new setback requirements match those contained in the State Code. For setbacks from property lines, no change was made. This is because the enhanced property line setback distance contained in the current Health Code does not permit someone to install a septic component that could potentially impact the ability of a neighbor to install a septic system. Additionally, Harding's old requirement that a septic bed be 25% larger or 125% of the State requirement was deemed no longer necessary based on decades of experience in other communities.

The revised Health Code also includes provisions for Advanced Wastewater Treatment technologies that have been approved by the NJDEP. these requirements can

reduce the required height of mounded systems that may be necessitated by high groundwater conditions or adverse soil conditions. Additionally, the use of such technologies can enhance environmental protection in situations where an existing septic system has failed and the on-site soils are less than ideal for wastewater disposal purpose.
