First Glimpse At Harding’s FY2018 Municipal Budget

CFO Himanshu Shah and Assistant Treasurer Andy Fiore presented the 2018 Municipal Budget to the Township Committee and members of the Public at the Committee’s January 15 regular meeting. The proposed budget, which makes up 25% of our property tax bill, is a 1.7% increase over 2017. This will result in a \$34 increase in taxes for the average home assessed at \$1.04 million. The largest increase was in municipal employees’ health insurance coverage which was indicated at \$1.23 million, or 13.6% of the entire budget, up approximately \$157 thousand from past year, after the Township received notification that its prior policy was discontinued. Mayor Yates and Deputy Mayor DiTosto indicated that this was a direct ramification of Obamacare, but that in 2018 the Township Committee would explore the feasibility of self-insuring while maintaining the appropriate coverage for its employees. The budget also calls for a \$50 thousand increase for Capital Budget (to \$750 thousand per year) for infrastructure investments including police vehicles, road improvements, and a new building at the Public Works facility. Township Committeeman Nic Platt also alerted residents that the Township must complete a property revaluation in 2020.

Final passage is slated for March 12 meeting. The public is invited to attend, ask questions, and participate in discussion on all items relating to the budget at this upcoming meeting.

Morris County Budget - A First Look

About 25% of your property taxes go to Morris County (MC). The other 75% stays in Harding for the school (about 50%) and municipal services (25% - police, DPW, Open Space, etc).

For years, Thumbnail has wanted to shine a light on where that money goes and dig into the \$300+ million budget of Morris County. Thumbnail just never had the “band width” to pull it off. But with the increase in volunteers we were able to start our examination.

At an open meeting on Feb 13, three Freeholders and the county executive discussed the drivers of the 2018 budget if not the actual dollar amounts.

Increasing spending are (a) salary increases (up about 2%), (b) costs to transition to self-funded prescription drug program for county employees - need to build reserve, (c) Increase in liability and workers comp insurance premiums, (d) employer pension increases (e) state human service/mental health cost increases, (f) investments in programs identified in Strategic Planning Process.

Decreasing spending are (a) Leasing of Morris View nursing home facility, (b) reduction in utility costs, (c) reduction in debt service and (d) reduction in capital expenses.

The leasing of Morris View, a nursing home on Hanover Avenue in Morris Plains, has been a significant financial drain for many years. Most municipal nursing homes across the state have been sold. MC uniquely chose to lease the facility to a commercial operator. Exiting by outright sale or leasing, removed 200 employees (nurses and aids) from the MC payroll and importantly for costs, removed them from the state pension system.

Morris View lease transaction closed Nov 1, 2017 so MC will begin to reap the benefits, described as “minimal”, in fiscal year 2018. In several years, the savings (avoided cost increases) will be \$7 million.

We asked if they could estimate if the tax levy would be going up, down or sideways and by how much. The response was that the budget would be revealed at Feb 28 meeting. We’ll be there.

Police Sergeant Thomas Downs Honored, Retires

The Township Committee voted to accept the retirement of Police Sargent Thomas Downs, after serving the residents of Harding Township since July 2001. Prior to joining Harding Police Department, Sargent Downs served on the Madison Police Department and was a Detective in the Morris County Prosecutor’s Office. The Township Committee extended its appreciation and congratulations for many years of dedicated service.

Board of Education

Board of Education Meeting 02-05-2018

Presentation and Discussion. The College of Saint Elizabeth/United Way collaborative gave an extensive presentation to the Board and public on the School Culture and Climate Initiative. Presenters were Patricia Heindel, Ph.D., Dean at the College and Elizabeth Warner of the United Way of Northern New Jersey. The *Initiative* has been working with 39 schools in the region, and with Harding for the last four years. The school climate and culture mission is “To ensure all children have the solid foundation and lifelong skills needed to thrive socially, emotionally, physically, and academically”. The data used to evaluate, institute changes, and then follow changes in a school’s “climate and culture” consist of acquiring and evaluating questionnaires and interviews from students (elementary and middle separate), staff (faculty, aids, administration), and parents over the three years. This presentation was the summary of the findings and changes in the culture and climate of the Harding school since the initiative’s initiation in 2013-2014.

The bottom line from the presentation was that significant positive increases were found in most key areas; for example, in such middle student areas as friendship, school connectedness, and school pride. The data from the staff cohort found significant positive increases in areas such as supportive leadership, quality of staff appraisal, and overall morale. For both elementary and middle school students, and for staff, the perception of frequency of bullying significantly decreased. Data from the parent group reported significant increases in general satisfaction with teachers, school climate, and their involvement with the school (although these parental factors had already been quite high in the initial survey in 2013-2014).

Much discussion with the Board and public ensued, including topics such as areas of needed continued focus (such as staff and student health, transition to Madison High School, school pride, on-going staff development), and what the next steps might be to follow on the successes of this culture and climate effort. Superintendent Report. Superintendent Matt Spelker reported that the monthly Harding-

Madison articulation between the two superintendents would occur on February 22nd. Madison Superintendent Mark Schwarz will attend the Harding Board of Education meeting on February 26th.

Superintendent Spelker also reported that the school's initial Strategic Planning meeting would convene on February 12th. Members of the planning group include staff, parents, and members of the Harding community including the mayor, fire department volunteers, and others.

Facilities and Finance. The Board unanimously approved the February 5, 2018, bill list in the amount of \$639,092. The Board also unanimously approved a contract for BAYADA Home Health Care Inc at the rate of \$60/hour for emergency backup nursing care if needed.

Facilities and Finance Chair Abi Singh reported that the HVAC project in the middle school was underway, and that more research is required before proceeding for the elementary school HVAC.

(Note: the purpose of this brief report is to help Harding residents connect with the School by highlighting significant items addressed by the Board and are not "meeting minutes". Minutes are filed by the Board Secretary and are placed on the Harding School website, generally about a month after the meeting date.)

Planning Board Meeting January 22, 2018

Declaration of Appointments by the Township Committee: Pending the election of officers, the meeting was called to order by Mr. Hall. He announced the appointments to the Board of Dev Modi (Class I), Tim Jones (Class III), Peter Saulnier (Class IV), Tom dePoortere (Class IV), David Chipperson (Class IV), Nik Bjorkedal (Alternate #1), and Gwenn Claytor (Alternate #2). He administered the oath of office to the appointees.

2018 Reorganization

1. Mr. Saulnier was unanimously elected Chairman. The meeting was turned over to Mr. Saulnier, and Mr. Clew was unanimously elected Vice Chair.
2. The resolution for professional services (to be provided by Messrs. Fox and Hall) was unanimously approved. No planner was approved since one was hired by the town. Mr. Saulnier noted that the professionals were not evaluated last year, and a plan was needed to do evaluations this year. Mr. Hall swore in Mr. Fox.
3. The resolution to set the meeting dates for 2018 was unanimously approved. Meetings will continue to be on the fourth Monday except for November and December when the meetings will be on the third Monday.
4. The resolution for "Do Not Exceed Limits" for professionals (\$8500 for Mr. Hall and \$4500 for Mr. Fox) was unanimously approved.

Minutes: The minutes of the meeting on and November 27, 2017 were approved without comment.

Announcements/Reports/Presentations

Mr. Saulnier welcomed Ms. Claytor as a new alternate Mr. Chipperson as a regular member of the Board. He then asked the Board to think about goals and objectives for this year. For example, should side variances for things such as play sets be relaxed? Possible issues for discussion should be emailed to Mr. Saulnier. Affordable housing continues to be a hot topic. The next conference with the judge will be on February 5th to establish parameters on an overall agreement. The Township Committee will be holding a volunteer seminar on February 24th which is hoped will improve linkages with all governmental bodies. Phil Rosenbach of the Board of Adjustment sent

an email looking for help interpreting the ordinance which allows accessory structures which contribute to the rural character of the town to be excluded from the building area. Mr. Clew reported that the Environmental Commission will be hosting a lecture on bats and a bat box building session at Town Hall; spring cleanup will be held on April 21st. Mr. Modi reported that the town is required to do a real estate tax re-evaluation in 2019, which will be put into effect in 2020. This is a tax neutral exercise with taxes on 1/3 of the properties expected to go up, 1/3 go down and 1/3 staying the same.

Applications

PB 04-16, Alan and Benjamin Franklin, 61 Village Road, Block 16, Lot 13. Minor subdivision. Request for Extension. There is an issue with the county concerning a road and applicant hasn't received county approval. Mr. Hall indicated that an extension was permissible, and the Board approved a six-month extension.

PB 02-17/4-10, GHK Realty II and GHK Realty III, LLC, 655 and 665 Spring Valley Road, Block 4, Lots 21 and 21.01. No action, incomplete. LOI has expired and the Board will wait for a new one.

Other Business

- Master Plan hearing on Proposed Amendments to Open Space Tables. Mr. Dietz is assisting Ms. Taglairino with table updates. Carried until next meeting.
- Mr. Edgar wondered about the appropriateness of having an applicant wait to address a relatively minor item until other business is concluded. Mr. Hall advised that the Chairman is free to change the agenda.
- Wireless Communication Nodes Coming to Harding

February 12th Township Committee Meeting

Verizon Wireless To Install 26 Network Nodes on Poles in Harding

A representative of Verizon Wireless informed attendees about the companies plan to use "small network nodes" to enhance coverage in Harding. When combined with a new tower at the DPW site, these boxes on poles will fix the cell service problem.

A node is a box (55x22x11 inches) that is attached to a pole 8-10 feet off the ground. At the top of the pole (35 ft) another box (22" long) is the antenna. The pole itself is the familiar telephone pole. Power for the nodes electronics is provided from an electrical cable from a nearby existing pole, usually across the street.

Verizon plans 26 of these nodes - 24 on new polls and two on existing poles. Depending on "line of site" issues, the poles will be 500 to 1000 feet apart to ensure coverage. The nodes are planned for Long Hill, Glen Alpin and Tempe Wick Roads.

Verizon Wireless rep said that the company "would love to use existing poles" to mount their equipment, but owners of the poles won't allow it. Those owners of the poles are Verizon Telecom (different from Verizon Wireless - who knew?!) and the electric company.

If T-Mobile and AT&T need to enhance their coverage, then one and ONLY one can co-locate their gear on these new poles. This would suggest that the 3rd carrier would need to install ANOTHER 24 poles.

Installation is not imminent and a public meeting on this will be held at an unspecified later date.

Fairchild Farm Garners First Ever Harding Historic House of the Year Award

The residence of John and Sally Quinn at 26 Lee's Hill Road was awarded the first ever "Historic House of the Year" from the Harding Historic Preservation Commission. Fairchild Farm is "a classic vernacular farmhouse of which the oldest part was built around 1750 by Joseph Fairchild (1724-1804) in what was then Passaic Township". Fairchild Farm is on the state and national registers of historic places.

Full Time Police Officer Sworn In - Force Back at Full Strength

Lukas Micoletti was sworn in to fill the vacancy created by the retirement of Sergeant Thomas Downs. Officer Micolette has experience from Wildwood at the Shore and has worked with Harding PD for a period already.

COAH News: 96 Townhouses To Be Built in Harding - 16 COAH eligible.

At the January TC meeting, an agreement between HT and Mt Kemble Associates LLC (a Kushner organization entity) was revealed to the public. The agreement allows Mt Kemble Associates (MKA) to build 96 housing units on the property behind the large office park on Rt 202, north of Blackwell Ave and south of Frederick Place.

The property is owned by the Kushner organization and, if you recall, was the focus of a plan by Morris Township to purchase/annex the land and build soccer fields. Harding scotched that plan thereby keeping the land in Harding. (At the time, Kushner quietly suggested that if HT didn't allow the sale of the property to MT, they would sell it to a mega-church from Newark.)

The current agreement was forced by MKA because they "intervened" in HT's affordable housing plan which is pending in front of the affordable housing czar - the so-called Special Master a judge who has absolute power to determine land use using affordable housing as the club. In this case, Harding was able to ensure that access to the 96 units will be through the office park (not Blackwell Ave) and that MTA will pay HT \$1 million.

If the plan is approved by the Special Master, sixteen of the 96 units will be designated as low and moderate income. HT's COAH obligation is not yet defined but is likely in the range 200-300 units.

Note that in this case, 96 total units are being built for HT to get 16 COAH credits. That's 6 times the number of COAH units. If HT's COAH obligation is 200-300, then it could mean that HT must allow 1200-1800 new housing units. This is a number that would change the character of HT in terms of land use and school population not to mention taxes. As the authority for these decision is from the NJ Supreme Court as a result of the historic Mt Laurel decision there is precious little a municipality can do.
