# PRELIMINARY SCHOOL BUDGET FOR '19-20 REVEALED - TAX LEVY UP 2%

At the first meeting of the new year (Jan 7), the Board of Education unveiled its first cut of the budget for the school year that runs from July 1, 2019 to June 30, 2020. Of interest to all Harding residents is that the budget calls for a 2% increase in the school related tax levy. School taxes account for almost 50% of a total Harding property tax bill. Again this year, the increase in the tax levy (except some allowable exemptions) is limited by state statute.

The budget calls for total spending of \$11.244 million, an increase of 1.8%. The school property taxes provide about 90% of that spending while the other 10% is provided by a myriad of items that are expected to increase less than 2%, hence the total spending will increase less (1.8%) than the tax levy (2%). These other sources (the 10%) of income are NJ state aid (\$272K), "budgeted fund balance" (\$335K), "extraordinary aid/non-public transportation" (\$224K), federal grants (\$137K), tuition revenue (\$98K) and miscellaneous items of revenue (about \$68K).

The 2% increase in school property compares with average ANNUAL increases of 6.01% for the

years 1997 to 2011 (before the cap was instituted) and increases that have since ranged between a low of 1.48% for school year 2017-18 and a high of 3.32% for the 2015-16 year.

On the expense side of the budget various items are increasing more than 2%. Teacher salaries, by far the largest item in a school budget, will rise 2.6% as per the contract with the union. Health and dental benefit premiums will increase. Out-of-District special education tuition, that is, spending to send certain children to other schools, is expected to increase 3-5%.

The plan includes funds some facilities upgrades: a bathroom renovation, HVAC project and STEM-Library/Media renovation, to modernize the library in line with 2020 technology standards.

The Superintendent's presentation listed 16 items that will be funded including safety related (Honeywell Instant Alert; safety upgrades; Safe School staff development), professional and curriculum development, software tool and systems and tech upgrades.

In late February, HT school district will receive final state aid figures. Then in mid-March, the tentative (as opposed to this "preliminary" budget) will be presented to the Board of Ed and submitted to the Executive County Superintendent. The public hearing on the budget will be in late April or early May with the new fiscal year beginning July 1.

# Planning Board Notes for December 17, 2018

The Township Committee appointed Alf Newlin to complete the term of Joe Schliefer, which expires December 31, 2020. The Board unanimously approved a resolution thanking Joe for his service on the Board which commenced in 2011. Minutes for the meeting on November 26, 2018 were approved without comment. Items in the liaison report from the Board of Adjustment included continued deliberations on the Post House town home development and a new application for a cell phone tower at DPW. Mr. Dietz reported that HOST was considering new acquisitions, but Mr. Clew indicated that acquisitions were unlikely while the COAH agreement was pending. The report out of the Township Committee indicated the ban on fox hunting was approved for three years. Mr. Saulnier indicated that the Board's reorganization meeting would be held on January 21, 2019. The Town Planner, McKinley Mertz, then went through all the sites that are included in the affordable housing agreement, and how the housing element of the master plan needed to be revised to accept these uses. Proposed changes to the master plan were approved by the Board so that the Township Committee could take further action such as revised ordinances to support the plan.

#### ANNUAL REORGANIZATION MEETING FOR TOWNSHIP COMMITTEE

On January 7, the Township Committee held its annual "reorganization meeting" where the "mayor" is selected (the citizens do NOT choose our mayor) and committee and liaisons are appointed.

First some background: in New Jersey, the 565 municipalities are organized as one of 5 different types - cities, boroughs, townships, towns, and village (only Loch Arbor). As well, there are 12 forms of government. Believe it or not, a municipality can have a "form" of government that is different from its "type." Consequently we see the "Township of the Borough of Glen Ridge." This form/type structure makes NJ one of the most, if not the most, complex states in terms of municipal government.

Little Harding (population about 3200) is a township which has a group of 5 elected officials (the township committee) which serves as both the Executive and Legislative authority. The township form of government is one of the oldest and is derived from the town meeting form used in New England, where a township committee has similar functions to the board of selectmen. A township committee can have either 3 or 5 members (we have 5 in Harding) elected at-large, i.e. directly by the people. Every year, the committee chooses one of its members to be the chairperson, commonly called the "mayor" to moderate meeting of the township committee but having no special powers. All legislative and executive powers are exercised by the committee as a whole. The committee may appoint an administrator to oversee day-to-day operations of the municipality. Harding has such an administrator in the person of Robert Falzarano. Of the 246 townships in NJ, only 144 actually use the township form of government.

At the annual reorganization, recently elected (none) or re-elected township committee persons (Tim Jones, Nanette DiTosto) were sworn in.

Chris Yates was again selected as the chair for 2019 and Tim Jones was selected as vice chair.

Assignments of the five TC members to 14 standing committees were made. Committees range from Finance & Insurance to Planning & Zoning to Technology.

And the TC announced the assignments of TC members and appointments of citizen volunteers to nine committees, boards and commissions, such as Citizens Park Advisory Committee, Environmental Commission, and Open Space Trust.

These assignments and appointments can be found on the Harding Township website, www.hardingnj.org - under the Documents and Forms tab, then Agendas & Minutes, then choose the agenda for the Reorg Meeting.

the Directory to be mailed in February. The directory will also include the function of each committee, contact data and information on how a resident can go about volunteering for appointment.

# TC MTG- AFFORDABLE HOUSING, GLEN ALPIN/HURSTMONT, MORE POLICE OFFICERS At the January 14, 2019 regular meeting of the Township Committee three major topics were covered.

First, a series of four ordinances were introduced that are needed to execute the Township's plan to comply with the Fair Housing mandate. We have discussed the plan at length in prior Thumbnail reports. These four ordinances will alter Township code to accommodate our COAH plan.

Second, the Township passed a resolution to allow Hurstmont Estate Acquisition LLC. to have access to the Glen Alpin Property (presumably with engineers and surveyors) to "determine the feasibility of utilizing a portion of the Property for an onsite wastewater discharge for the Hurstmont Estate development". Hurstmont Estate Acquisition is under contract to purchase the Hurstmont property, which is contiguous to Glen Alpin. Hurstmont Estate Acquisition seeks to build an assisted living facility on the former Hurstmont mansion site and is now investigating the purchase of Glen Alpin and using some of the land for a septic system. Of course the purchase would be part of the Harding's "diversion plan" to put Glen Alpin in private hands. The GA structure would remain and not be demolished as per the terms of the diversion. Members of the public expressed concern that there could be unmarked graves, possibly of slaves of African descent, on the site as the original owner was thought to have over 20 slaves. More recently, a person was reputed to have found bones while gardening. The resolution passed unanimously.

Third and most importantly, an ordinance was introduced to increase the number of sergeants from four to five. This seemingly minor change is part of a plan to re-organize and expand the Police Department by two officers. The re-organization would create a Support Service Division and a Patrol Division, a structure that was called "best practice." The Support Division, headed by one of the sergeants, would perform investigatory follow-up of which there is little to none now and help to increase the case clearance and property recovery rate. It would also handle training, fire arms applications and other tasks. At least in the short run, the plan is expected to save money by reducing overtime and compensatory pay. A Special Meeting of the TC is scheduled for January 28 at 7:30pm to consider again and pass this ordinance.

# **NEW VERNON FIRST AID SQUAD**

When you call 911, your call is routed to a specially trained dispatcher at the Morris County Office of Emergency Management, who, through a series of carefully selected questions, identifies the emergency, the current status of the patient(s), and dispatches all of the

necessary resources including police, fire, paramedics and the First Aid Squad. While the dispatcher continues to get more information from the caller, these resources are en route to the patient. Additional information received by the dispatcher is then passed on to en route resources by radio.

The New Vernon Volunteer Rescue Squad responds to 911 calls in Harding 24/7. 2018 was no exception. The First Aid Squad cared for 375 patients. The medical emergencies included 2 CPR calls, 133 medical calls, 50 traffic accidents, 44 falls/fractures, 26 calls for cardiac issues, 23 calls for altered mental status, 20 calls for shortness of breath or difficulty breathing, 18 calls for lacerations or bleeding, 17 calls for fainting or seizures, 13 fire calls, 13 calls for pain, 11 calls for trauma and 5 calls for strokes. In October 2018 alone, the First Aid Squad handled calls for a record 50 patients, the highest number ever recorded in a single month.

Beyond responses to private residences and local Harding Streets, the First Aid Squad responded to emergencies at the Harding School, Wightman's Farm, the Minuteman Smokehouse & Grill, the Market Restaurant, Jockey Hollow National Park, The Great Swamp, the Kemmerer Library, The Church of Christ the King, the First Presbyterian Church, and the Kirby Municipal building. The Squad also serves 7 miles of Interstate 287, and responds to mutual aid calls in surrounding communities. In addition, our trained instructors offer occasional CPR classes to Harding residents

In order to continue to provide the 24/7 level of excellent care that Harding has come to expect of the First Aid Squad, we need new members as drivers, First Responders and EMT's to replace those members who retire due to age, illness or relocation. The First Aid Squad provides all training for its volunteers. **Please join us now!**

# Financial Report - December 31, 2018

At December 31, 2018, the Harding Township Civic Association had total assets of \$40,702 and accrued liabilities of \$275 or a net worth of \$40,427.

During 2016, the Association had total receipts of \$22,736, primarily from dues and donations, and total expenses of \$25,387, which included the accrued expenses at yearend of \$275. Thus, the net loss during 2016 was \$2,650.

Expenses are primarily associated with the publication and mailing of the Thumbnail and the Association's directory. The Association has taken steps to bring its expense within its current income levels.

Less than 1/3 of Harding households responded this year to the Association's dues solicitation

request. The Association appreciates the support it receives from residents, but encourages all residents to support its mission to create an informed and engaged citizenry and to foster patriotism. The HTCA is an independent, non-political organization not affiliated with Harding Township government or any political party.

<u>Commingled Recyclables</u>: Consists of all aluminum and tin cans, glass bottles, all plastic bottles and containers with the Recycling symbol, and #1, 2, 4, 5 & 7. Try to crush plastic bottle to conserve space. Please remember no plastic or paper bags.

<u>Commingled Mixed Fiber:</u> Recycling: consists of all paper, cardboard, newspaper, office paper, magazines, and books. Please put loose or shredded paper in paper bag. Please flatten all boxes or fill with other paper products.

<u>Other Accepted Items</u>: Batteries; automotive (car) and household (rechargeable accepted); Automotive and light truck tires, (on or off rim), Propane tanks (BBQ size only) and fluorescent bulbs (tube and compact).

<u>E-Waste items accepted</u>: Computers, monitors, laptops and televisions <u>cannot</u> be put into household trash.
