#### WE CAN NOW RECYCLE PLASTIC BAGS

The Recycling Center at the Dept. of Public Works will continue accepting plastic bags as it did during the Library's very successful plastic bag collection program. CLEAN plastic bags can be put in the white box with green letters located between two of the big dumpsters.

Virtually any bags will be accepted if CLEAN: Produce bags, store bags, ice bags, ziplok, cereal box liners, case over wrap, bread bags, newspaper sleeves, dry cleaning bags, bubble wrap, and plastic e-commerce mailers.

# **BOARD OF EDUCATION**

Board of Ed Commences Budget Process for 2020-21 School Year The budget will be developed under the following guidelines:

- 1. Develop a prudent budget that is aligned with the district's instructional priorities, addresses the needs of all our students and allocates sufficient funds to ensure professional development for staff.
- 2. Maintain district's fund balance at a maximum level permitted by State law.
- 3. Maintain staffing configuration and curriculum programs for the 2020-2021 school year. (i.e. small class size)

- 4. Continue to ensure that the budget and financial planning process is integrated and aligned with district priorities and includes planning objectives based on statewide assessments and the 2019-2024 HTS Strategic Plan.
- 5. Continue to be value-oriented and conservative in the expenditure of public moneys, respecting its effect on local taxpayers.
- 6. Continue to provide financial support for the revision of curriculum as per the Curriculum Review Cycle.
- 7. Allocate funds for the District Technology Plan, all leased equipment, and for Capital Improvements, as detailed in the Long-Range Facilities Plan and Comprehensive Maintenance Plan, and as recommended by the Facilities and Finance Committee.
- 8. Continue to fund all programs and services and foster educational excellence, working within the confines of the 2% property tax cap, as per State law.
- 9. Derive budget expenditures from competitive supplier quotations, whenever appropriate, official data and actual expenditures from previous years. The concept of zero-based budgeting shall be followed.

# **PLANNING BOARD**

# Planning Board Notes for October 28, 2019

The main order of business was to get input from the public on the Master Plan Reexamination and the Open Space and Recreation Element which are subject to periodic review. These plans are used by the Township Committee, the Board of Adjustment and the Planning Board to guide decision making relating to township development activities, and cover such matters land use, zoning and quality of life. The Township Planner, McKinley Mertz, collected input from the public. The first area covered "Priorities for Harding 2030," and included such topics as Agriculture and Farming, Historic Resources and Rural Character. The second area covered "Goals, Targets and Visioning for Harding 2030," and included the challenges facing Harding and potential solutions for the challenges. There were also two visual preference surveys which invited input on the "Commercial Architectural Character in Harding" and "Open Space and Recreation in Harding." Members of the public expressed their preferences with colored dots (yea and nay) on the various alternatives that were presented. After the data were collected, the Board engaged

in a lengthy discussion on what form the planner's reports would take. Many felt the current plans were in good shape and only need to be marked up with suggested changes, rather than starting with blank sheets. The Board was assured that only recommended changes would be made to bring the plans up to date.

Mr. Saulnier reminded everyone about next month's public meeting to discuss the Master Plan. One issue that has bubbled up recently is noise, particularly that of chain saws being used in the middle of the night. Mr. Hall reported that the GHK Realty Application for Fawn Hill Farm on Spring Valley Road has officially expired, and a new application would need to be filed. Most of the meeting was used to review amendments to the Hurstmont re-development plan. The original plan was formed prior to the designation of a re-developer, and the re-developer who has been designated is proposing amendments. The Board must determine if the changes are consistent with the Master Plan. Town Planner McKinley Mertz walked through the revisions. The classification of the facility is being changed from a "continuing care retirement facility" to "a la carte." This will allow townhouse owners to re-sell their properties and buy into amenities. Physical aspects of the development (driveways, lighting, access, signage, etc.) were reviewed. The developer is allocating two acres for a public walking trail. A more sophisticated septic system is being proposed to handle the daily volume. Impervious coverage is being increased due to road widening required by the Fire Department. Parking will be underground, and the architectural style of the buildings will include natural materials throughout. Landscaping and tree planting were included in the plan. The Board concluded the changes were consistent with the Master Plan, and a resolution to that effect (along with recommended changes) was approved. The Board will have the opportunity for further scrutiny of the re-development when the final plans are submitted for approval

# **TOWNSHIP COMMITTEE**

# Township Committee Meeting - October 21 - Nothing Exciting

The October 21 Meeting of the Township Committee had no surprises. The finances of Farm at Harding were reviewed again but no decision was made nor ordinance introduced regarding a possible disposition. We covered this potential

transaction in the October Thumbnail so readers can check that report out - in fact the September meeting communicated more insight into the contemplated transaction than the October meeting. In very brief summary, The Farm at Harding, our Township owned low income housing project (at Kitchell Rd and Woodland Ave), loses money and is facing likely large capital costs over the next 10 years. Harding

can get rid of the facility with a sale to the Housing Authority of Madison and then use the proceeds and other COAH funds to retire the debt.

Committee person, Nic Platt, told attendees about a new cell phone app (called Boxcar) that can solve the problem of parking for train commuters. Again we wrote about this in last month's Thumbnail. You can get the app on Apple store app.

Lastly, Harding's financial professional, Andy Fiore, reviewed Township finances through Q3. The bottom line is that Township is tracking at or better than budget.

### **ENVIRONMENTAL COMMISSION**

The November 2 meeting addressed the following matters:

- 1. The Master Plan Review by the Planning Board and what areas require our attention and consideration.
- 2. Among the issues requiring review are our open space and recreational needs, whether or not we are in conformity with Green Acres requirements, and the revision of the Route 202 Corridor with respect to changes for the construction of the Affordable Housing.
- 3. The Master Plan is required by State Law to be reviewed every 10 years. The Plan reflects the way the Township develops.
- 4. The goal of the Plan is to protect water, land, open space, and wildlife and conservation, generally.
- 5. Public input, recommendations, and concerns would be appreciated.
- 6. The Rolling Knolls recommendation for disposal have been postponed pending a meeting between the EPA and the Fish and Wildlife Commission; and further discussions were had on the Living Landscape and doing additional census on healthy flora and fauna, anticipating the lecture on this matter by Dr. Doug Tallamy.

# **Avoiding Falls**

Falls are second only to motor vehicle accidents in the number of calls that the FAS responds to each year. Whether it is a fall from a ladder, down the stairs or simply a fall from a standing position, generally speaking, falls impact older residents more frequently and more severely than younger residents. Young or old, falls can result in serious trauma, from broken bones, bleeding, including internal bleeding, strains, sprains and even possibly death.

What can you do to minimize falls?

When using a ladder, check to make sure that the ladder is functionally stable and is in good condition. Make sure the feet of the ladder are firmly planted and level. Never go above the recommended highest step (generally the step below the top step). Use a ladder or step stool, not a chair, to reach the top shelf.

Clear stairs. Do not place items on the stairs to later be taken upstairs. Items on the staircase may not be seen by someone going up or down and could result in a loss of balance and a fall.

Check throw rugs to make sure that they do not move and lie flat. If the throw rug will slide on the floor below or a corner can flip up, a trip hazard exists. While

elderly persons are most at risk for falls from throw rugs, anyone could trip and fall possibly striking their head on a nearby object.

Be safe, check your home for trip hazards.
